The meeting was called to order at 1 p.m. by Chairman John LeMoyne.

Seven water district members in attendance and two representatives of the Water Resources Department.

Minutes of the 1990 meeting were read and approved.

Election of officers for the forthcoming year:

Moved by Bill Jones and seconded by Lynn Babington that the officers for 1990-91 be re-elected. Passed unanimously. (Chairman - John LeMoyne & Secretary - Dave Bruhn).

#### Business:

Chairman LeMoyne advised that, according to Water Resources Department, the Water District 36A Watermaster need not be covered by Workmen's Compensation.

Question was raised about water measuring weirs on diversions. This is a responsibility of the individual ditch companies; not the Water District.

### Watermaster Budget:

Moved by Lynn Babington, seconded by Dave Bruhn that the Watermaster be compensated at the rate of \$10 per hour and \$0.30 per mile; individual calling for services to pay. Passed unanimously.

Dan Yore, representing Buckeye Ranch, raised the question about Watermaster's responsibilities. Chairman LeMoyne replied the responsibilities are to determine water flow and allocate water based on priority rights.

### Election of Watermaster:

Moved by Lynn Babington and seconded by Myrle Eckles that George Lemmon be elected Watermaster. Passed unanimously.

### Other Items:

Chairman LeMoyne reported on Senate Bill 1061 in the Idaho Legislature. Bill establishes a revised method of determining voting shares for water districts. Legislation is prompted by inordinate shares enjoyed by hydroelectric producers.

Steve Clelland, Water Resources Department discussed the process of the Snake River Water Rights Adjudication:

- (1) New claims are filed by the user.
- (2) Water Resources Department reviews the filing and makes a determination as to acceptability.
- (3) Department recommends to the court the amount deemed appropriate.
- (4) The court entertains objections; and negotiations occur if needed.
- (5) If agreement cannot be negotiated; question will go to litigation.
- (6) Court will ultimately issue a decree.

March 6, 1989

The meeting was called to order at 1 p.m. by Chairman John Lemoyne.

Twelve persons in attendance.

Minutes of the 1988 annual meeting were read and approved.

Election of officers for forthcoming year was held:

John LeMoyne & Jerry Veenendahl nominated as Chairman. LeMoyne elected.

Dave Bruhn nominated and elected as Secretary.

### Business:

Chairman LeMoyne read the Idaho Law establishing the basis for voting, and the number of votes based on water rights, relative to business conducted by District 36A.

Chairman LeMoyne read a letter of April 11, 1988 from Idaho Department of Water Resources; responding to District 36A's letter of March 10, 1988 regarding effects of irrigation pumping on Billingsley Creek water flows.

Ed Shokal reported for the committee which researched options in administering District 36A:

- (1) Continue operating as in the past.
- (2) Allow the State of Idaho to administer the District.
- (3) Gooding County assess the water users with the County allocating funds to the District. Shokal felt it was worthy of consideration. An assessment of SO.01 per inch of water would generate approximately \$909 annually for the District.

No action taken on this subject.

George Lemmon, Watermaster, reported the inspection of all major diversions on Billingsley Creek. accompanied by Gary Funderburg, Water Resources Department, and Marne Mercer. All diversions looked satisfactory.

George Lemmon provided flow data for Billingsley Creek at Rangens, and continuing on down the creek for major diversions. Measurements totaled approximately 98.8 CFS. Measurements taken March 1, 1989.

Lemmon reported being called June 29, 1988 to accomplish Billingsley Creek flow measurements. Total flow measured about 131 CFS.

Lemmon reported flow measurements taken at Rangen's measuring station over a period of time. Annual average flows for 1987 were 40.6 CFS and for 1988 were 35.1 CFS.

Donnie McFadden initiated discussion on the concept of combining District 36A Watermaster duties with ditchrider duties for major Billingsley Creek diversions. Costs would be paid off the tax rolls. Considerable discussion followed. Concerns included charges to individuals with pipelines rather than ditches; and the inequities therein. No action taken.

# Watermaster Budget

Dave Bruhn moved, seconded by Ed Shokal, that compensation for the Water-master, for 1989-90, be set at \$10.00 per hour and 30 cents per mile; individual calling for services to pay. Motion passed.

# Election of Watermaster

George Lemmon & Cleve Lloyd nominated. Lemmon elected.

The meeting adjourned at 2:45 p.m.

Ed Shokal asked IDWR to define Water District 36A. "Water District 36A includes, by court decree, Billingsley Creek and Riley Creek drainages."

Ed Shokal moved that a letter be sent to IDWR expressing concern about the effects of well pumping on Billingsley Creek. Seconded by Gretchen Uppiano. Motion passed.

Marne Mercer expressed favor for adopting a formal budget for the District. Pros and cons were discussed.

IDWR explained that the basis for determining the number of votes, at the meeting, was based on the quantity of water in the individual, association, etc. water right.

Considerable discussion occurred relative to options in administering the District. Lawrence Smith moved, seconded by Anita Anderson, that the District Chairman appoint a committee to explore options in future administration of the District. Methods of administering other Water Districts will be evaluated. The committee to report back at the 1989 Annual Water District Meeting. Motion passed.

Donnie McFadden moved, seconded by Ed Shokal, that the District Watermaster accomplish quarterly water measurements, for one year, of all major water diversions on Billingsley and Riley Creeks. Motion passed.

Mr. Watson moved, seconded by Marne Mercer, that compensation for the Watermaster, for 1988-89, be set at \$10.00 per hour and 30 cents per mile; individual calling for the services to pay. Motion passed.

Election of Watermaster was held. Nominated were S. Carlton, George Lemmon and Lawrence Smith. Lemmon elected.

Chairman LeMoyne appointed Donnie McFadden, Ed Shokal, George Lemmon and Myrle Eckles as the committee to evaluate options in administering the District. Committee to report back at the 1989 District meeting.

Watermaster nomination was for George Lemmon. Unanimous vote. Watermaster compensation was set at 20¢ per mile and \$7.50.


Billingsley Creek Flow is at 33.6 cfs. Normal February flow is 39 cfs.

The meeting was called to order at 1:10 PM Marchh5, 1979, by Louis Koopman,

Pres. Minutes of March 6, 1978 meeting were read by the secretary and were
approved as read.

Mrs. V C Bell was elected as secretary.

A motion was made that Mr. George Lemmon continue as the Watermaster for District 36-A for 1979. The vote was unanimous. Wages for the Watermaster were set at \$7.50 per hour and 20¢ per mile. Unanimous vote.

## Boundaries for District 36-A.

George Lemmon presented a letter that the District 36-A Boundary Committee sent to the Dept of Water Resources Feb.6, 1979. No reply received as of March 5, 1979.

A motion was made and seconded & voted unanimously to accept the committee's recommednation. The boundaries for District 36-A include the areas on the North side of Snake River below the rim from I-80N crossing west of Bliss upstream to the Perrine ERidge north of Twin Falls.

Mr George Lemmon reported that he had contacted the Southern region Dept of Water Resources concerning locking measuring devices for Billingsley and Riley Creeks. Mr. Lemmon had received no reply as yet from the Dept of Water Resources.

Rechafte of Aquafier discussed - Mr Lemmon advised that last years bill was to be updated and Governor Evans to be encouraged to sign the bill.

Edward C. Shokal Secretary pro-tem Water District 36-A The Meeting was called to order at 1:10 P.M. by Louis Koopman, Président. Minutes of March 7, 1977 meeting were read by O. Anderson, Secretary-Treasurer, and were approved as read.

Mr. O. Anderson submitted his resignation as Secretary-Treasurer of District 36-A and Mr. L. Koopman accepted it with regret and thanked Mr. Anderson for his generous service as Sect.-Treas. for so many years.

Mr. L. Koopman requested Mr. Ed. Shokal to act as Secretary, pro-tem for this meeting until a new Secretary-Treasurer was elected.

After several nominations were made, Mr. Donny McFadden of the Buckeye Land Co. was unanimously voted into office. Mr. McFadden was not present so he will be notified of his election by Mr. L. Koopman.

A MOTION WAS MADE that Mr. George Lemmon was to continue being the Watermaster for District 36-A for 1978. The motion was the maintained by vote.

Mr. Michael Steele, Southern Region Supervisor and Mr. Jim Stanton of the southern region of the State of Idaho Dept. of Water Resources, were invited guests. Mr. M. Steele gave background information on how the water administration of District 36-A is repidly changing. He stated that in recent years many new water permits were applied for and issued and that now winter water use is becoming more in demand. Billingsley Creek was mentioned as a problem area because there are many points of diversion on the creek, and practically none of them are controllable and measurable, and they have valid water permits dating from the 1800's to the present time. Problems could develop if all the water users on the Billengsley Creek did not get their full quota of water. Riley Creek was also mentioned as being over-subscribed.

Mr. Mike Fenen asked for an explanation on how the watermaster controls or acts on the above situations.

Mr. George Lemmon, Watermaster for 36-A replied he would answer to the call of the problem when a complaint arose, but up to this time there were few calls.

Mr. M. Fennen then asked Mr. M. Steele for advice on what procedure had to be followed to get measuring devices installed at the points of diversion along the Billingsley Creek.

Mr. M. Steele replied that the water users have to put their

request through the watermaster, Mr. G. Lemmon, to the southern regional office. The office will then follow established procedures and hold meetings with the water users to explain what is involved in getting the measuring devices installed. He also said that once it is clear to the water users they want the measusring devices installed, they will have to follow through and complete the entire project within a reasonable time that will be set by the southern regional office. It was also made clear that the water users will have to pay for their own measuring device. It was also made clear that all the above discussion was related to the point of diversion from the natural water way, that is the Billingsley or Riley Creeks and that the ditch users will have to work out their own method of regulating the water among their local ditch water users.

Mr. M. Fennen asked Mr. G. Lemmon what his opinion was as to the need of measuring gates.

Mr. G. Lemmon replied that it was his opinion that we are rapidly approaching the time when "the old way" is getting very difficult to operate by. Mr. G. Lemmon added that the controlled gate method of operation could easily triple the cost of controlling the operation. In the past there was very little control.

Mr. L. Koopman addressed the meeting saying that three subjects should be discussed or settled:

- (1) Boundaries of District 36-A(2) Locking-measuring gates
- (3) Pay for Watermaster.
- Mr. G. Lemmon said regarding the boundaries of 36-A, he requested the State of Idaho Dept. of Water Resources for the 36-A boundaries and was told that the 1932 decree was it. He continued with details how this was not specific enough to be truly definitive. He added, he is requested to make calls as a watermaster in areas that are outside this 1932 decree. Blue Lakes, near Twin Falls was mentioned as one boundary, but that was also uncertain.
- Mr. E. Shokal asked that the boundary of 36-A be obtained and put in writing because this question came up at the last 3 meetings. He also asked for a study to be made as to why any particular boundary be chosen for 36-A so that District 36-A will not be made any larger than necessary to properly serve the high density area of 36-A.
- Mr. R. Cook said he want to know why District 36-A had to be extended beyond Gooding County boundary lines. It could complicate future tax collection procedures and assessments.
- Mr. E. Shokal MADE A MOTION to establish a committee to assist Mr. G. Lemmon in getting the boundarys of District 36-A established. Motion PASSED. Mr. L. Koopman directed Mr. G. Lemmon to select

his committee. Mr. G. Lemmon asked Mr. J. LeMoyne and Mr. M. Fennen to be the committee and they accepted. The committee will report their results on establishing the boundary of District 36-A at the 1979 meeting.

Mr. L. Koopman asked for discussion of water control at diversion points along the creeks.

Mr. M. Steele read Idaho Code 42-701 to the group and then made it clear that the State is not asking for any changes now, he emphasized that this is (installation of controlled water-gates) voluntary by the water users and that control devices are only necessary when the water supply is short. This was followed by a discussion by the members on several related points of detail.

Mr. M. Fennen MADE A MOTION that the State of Idaho Dept. of Water Resources, Southern Division, request the valid water users of District 36-A to install measuring devices and locking gates at their points of diversion from the Billingsley and Riley Creeks. The motion was seconded by Mr. J. LeMoyne. The vote was 15 approved and 0 opposed the motion. Motion passed.

Mr. L. Koopman then instructed Mr. G. Lemmon to write a request to the Twin Falls Dept. of Vater Resources, for the gates.

Pay for water. Mr. J. LeMoyne MADE A MOTION that Mr. G. Lemmon be paid in the year of 1978 at the same rate be was paid in 1977. Mr. O. Anderson seconded. The motion passed.

Mr. C. Lloyd raised the question of how all these gates and measuring devices are going to be installed to comply with the Federal Clean Water-Pollution laws. He was concerned about getting silt in the streams.

Mr. Steele answered the question by stating it was his best opinion that these gates could be installed by working with the Twin Falls Office of the State of Idaho Dept. of Water Resources and that then it will not be necessary to get a stream channel permit from the Army Corps of Engineers. Hr. Steele then elaborated how they are working together with the Federal people so that these small projects could be implemented without being excessively burdened with red tape.

Mr. G. Lemmon exibited two charts he made using measurements of water flow on a monthly and annual rate, taken at the head of Billingsley Creek. These charts show the water flow has definitely been reduced in recent years, even when the monthly flow rates are considered. Approximately 51 cu./ft./sec. flowed in 1966. It peaked to 59 cu.ft.sec. in 1972 and then has rapidly dropped to 38 cu.ft.sec. in 1977.

Mr. LeMoyne MADE A MOTION to adjourn the meeting. Mr. C. Anderson seconded the motion.

Meeting was adjourned at 2:55 P.M.

- (1) Members of Water district 36-A gathered in Hagerman High School for their annual meeting. President Koopman and Secretary O. Anderson were absent because they were subpoensed for a court hearing in Gooding.
- (2) Mr. George Lemon, being Watermaster, asked Mr. Edward Shokal to be pro-tem Secretary and Mr. Gordon Dahlgren to be pro-tem Chairman.
