The meeting was called to order by Ronald Hamm, President, 1:05 p.m.

In attendance: Ronald Hamm, Lynn Rasmussen

Prior to the call to order, copies of the 2010 minutes were handed out to members in lieu of reading them aloud. The minutes were accepted as written by a show of hands.

1<sup>st</sup> order of business: nomination and election of president and secretary.

Leon Anderson motioned to retain Ronald Hamm and Ann Hamm as president and secretary, respectively. The motion was seconded by Roven Gunnell and approved by a majority show of hands.

2<sup>nd</sup> order of business: selection of Credential Committee (Advisory Committee)

It was questioned as to what the Credential Committee was and a discussion followed. It was decided that the Advisory Committee could/would act in the same capacity as a Credential Committee and Leon Anderson motioned to keep the Advisory Committee --------- Ron Hamm, Tod Jensen, and Robert Harris in place. The motion was seconded by Lynn Rasmussen and approved by a show of hands.

3<sup>rd</sup> order of business: compensation of water master and secretary.

The budget was presented by the president. The question of billing was discussed as to whether to keep the county as the collector of the maintenance fees or having a bank account and filing our own billing. Lynn Rasmussen suggested that it was (expeditious) to keep the present system of having the county collect the fees.

Charleena Anderson mentioned that with rising costs the water master should be compensated at an increased rate. No further discussion was offered and a motion was made by Leon Anderson and seconded by Roven Gunnell to keep the current compensation as last year.

4<sup>th</sup> order of business: nomination and election of Water Master.

There were no volunteers or new nominations.

Charleena Anderson motioned to keep the same water master as last year, (Lynn Rasmussen), Michael Tingey seconded the motion and it was approved by show of hands.

5<sup>th</sup> order of business: old business

No old business was address.

6<sup>th</sup> order of business: new business.

Michael Tingey asked what others might need to have done. Roven Gunnell asked if he could cut the willows behind his farm along the canal. No problem with his suggestion. Lynn Rasmussen asked if beavers were causing a problem or if they had been seen. No issues with anything on the canal at this time.

The meeting was adjourned at 1:25 p.m.
