1:05 Nolan call the meeting to order. Alan Harper moves that Nolan Branch remain as Chairman. Jay Harper 2nd. All was in favor.

Nolan welcomes Benny Walker and Nathan Erickson from the water resources' office of Twin Falls.

Rick the read minutes from the 2010 meeting, Nolan ask for any corrections or comments, Jay moves that minutes accepted as read. Jeff Johnson 2nd. All was in favor. Mike Lewis moves we dispense with the credentials committee, Mike Spencer 2nd all was in favor. Nolan asked if Rick will remain as water master and secretary Alan asked about wages of water master. Rick stated the wages was \$25.00 per hour and water master used personal pickup and buys the fuel. Discussion was made as to wages, Alan moves wages go up to \$30.00 per hour to cover fuel cost. Discussion was made as to the Ground Water District's recharge program and that at one point in time, it was using flow needed to fill a stock water right. Alan moves that a letter be sent to the Ground Water District. It will be requested that they notify the water master when ever they take surface water for recharge and to keep water master informed of usage. Jeff 2nd all was in favor. Rick is to write the letter and Nolan will sign the letter.

Nolan calls for new business. Discussion was made as to the weirs and water rights.

Nolan adjourned meeting at 3:03 PM.
