BE IT FURTHER RESOLVED that no water be delivered by the Watermaster of this District to any water user until such time as the assessments for such water user are paid in full."



Discussion followed concerning a wash problem on a cross cut ditch through the Swan Land & Livestock Company property and also a wash problem on a crossing of the same ditch through the Devil Creek Ranch, Inc., property. After discussion of the matter, arrangements were discussed whereby work would be done during the 1976 irrigation season to correct these problems.

There being no further business to come before the meeting, the same was adjourned.

RESOLUTIONS PERTAINING TO THE TIME AND MANNER OF COLLECTING THE BUDGET AS
ADOPTED AT THE ANNUAL MEETING OF THE WATER USERS OF

WATER DISTRICT No. 47-C

It being desirable that a date different from that provided by statutes, i.e., June 1st, be fixed as the final date upon which the amount payable from each water user as shown by the adopted budget shall become due.

Now, therefore, BE IT RESOLVED, that the amounts payable by each wateruser as shown by the approved budget, shall become due and payable on May 1, 1976, and said amounts, if not so paid, shall bear interest from that date until paid at the rate of eight percent per annum.
