The annual meeting of Dictrict 47-0, Rock Creek Water Users met at the home of Charlotte Crockett, Monday, March 2, 1987 at 2:00 p.m. There were seven members present.

Dennis Butler was elected to act as chairman of the meeting and Charlotte Crocket; as secretary-treasurer.

A motion was made by David Crockett that at King be elected to be watermaster for the year of 1987, he stated that he is to be paid a salary of four thousand deliars; (\$4020), to be paid on a contract basis over a six month period. Clifton Haynes seconded the motion; motion carried unanimously.

Keith Rhodes made the motion that Charlotte Crockett serve as secretary-treasurer for the sum of four hundred fifty dollars (\$450) for wages and supplies. Ed King seconded the motion; motion carried.

The yearly budget was set at forty-eight hundred dollars (**4800). Chairman Dennis Butler asked Clifton Hayes, David Crockett and Keith Rhodes to act as an Advisory Committee for the 1987 irrigation season.

Meeting adjourned by chairman, Dennis Bulter.

RESOLUTIONS:

The Advisory Board stated that all water bills past and present must be paid not later than the fifteenth day of May, 1987. If the bill is not paid the deliquent user is to receive no water.

The resolution was made that the watermaster or Advisory Board be subject to call for the entire 12 months, from the March 2, 1987 election to the election in March of 1988.

The annual meeting of the 47-0 Water District users of Rock Creek water met at the home of Charlotte Crockett, March 7, 1988 at 2:00 P.M. There were fourteen members present. Jim Stanton attended the meeting representing the Water Resource Board.

Todd Claiborn was chosen to act as chairman of the meeting. Charlotte Crockett was elected as Secretary-Treasurer.

The 1987 minutes were read and a financial report was given. Both were approved.

Ed King was elected to serve as Water Master for the year 1988. The motion was made by Neil Larsen that Ed be paid the sum of \$4000 to be paid on a contract basis over a six month period. Keith Rhodes seconded the motion and it passed by a unanimous ballot.

Charlotte Crockett is to receive the same as the previous years, \$450.00, for the year's supplies and wages. This office is also on a contract basis.

Walt Freestone made the motion the budget for the 1988 irrigation season be \$4800. Ted Crockett seconded and it passed.

Bob Wartgow and Wayland McClellan were at the meeting to inquire as to their water rights, for the subdivision property they own in the Rock Creek Water District. Hal Frazier stated that some parcels of the Sunflower Ranch were to receive three (3) inches of Rock Creek water for each 5 acres. Jim Stanton said water could not be decreed to said acres unless it had previously used Rock Creek water to irrigate the area.

Charlotte Crockett made the motion that the land owners who are legally entitled Rock Creek water be allowed to pump it out of the creek contingent upon the land owners forming an association to police the decreed water rights within the subdivision.

Discussions were held concerning how the amounts of water could be accurately measured. bob Wartgow stated it could easily be measured with a water meter. Ted Crockett then seconded the motion, voting was tied. Todd Claiborn then voted for said motion, and it passed.

Chairman Claiborn chose Keith Rhodes, Neil larsen and Walt Freestone to act as an advisory board for the irrigation season.

Dennis Butler moved the meeting be adjourned.



The total assessment from the water district to cover expected expenses is to be \$2850.00. Jack Claiborn made the motion that we budget \$3550.00 for the year of 1978 and 79. Keith Rhodes seconded the motion, it carried. This second amount was to be budged in the event we needed to use the extra amount of money we have deposited in the bank..

Von Nebeker made the moltion that the secretary receive \$350.00 for the years expenses and work. Keith Rhodes œconded the motion, it carried.

The resolution was made that all bills, including delinquentones from the previous year, be collected by May first, and that the water master be instructed to refuse water to anyone not having his bill paid.

Charlotte Crockett was elected to be the secretary, treasure for the year and is to be paid \$300.00 for wages and expenses.


