WATER DISTRICT MEETING NOTES

Elsie Riggs called the water district to order. Sam Blackwell was not able to attend the meeting. Elsie read the minutes, which were approved. There was no old or new business discussed. I informed the district at this time about the need to provide information to the department in a prompt manner. The officers were nominated and Sam Blackwell asked to be removed from president. The district elected Lee Blackwell as president, and re-elected Elsie Riggs as secretary. Teresa McCallum nominated Jim Allen to continue as watermaster, and Mr. Allen was unanimously approved.

The watermaster fee was increased from \$50.00 per trip to \$60.00 per trip. A \$50.00 budget was granted to the secretary for office supplies.

The adoption of resolutions was brought onto the floor. None of the district members knew exactly what would be needed to create a set of bylaws or rules for the district. I told them that I would consult with John Westra about putting together a set of rules and bylaws that other districts have adopted. I told them that I would mail these out to them within the next few weeks.

The next meeting was set for the second Monday in January at 2:30.
