Minutes for Water Meeting District 11A Eight mile-Bailey Creek 2008

Garth Monroe brought the meeting to order at 1:03 p.m. Monday, March 03, 2008.

Water users in attendance this year were Dusty Moore, Lynn Harris, Ralph Hopkins, Chuck Schvaneveldt, Casey Quinn, Garth and Robin Monroe.

A nomination for Robin Monroe for secretary was made by Dusty Moore and Lynn Harris seconded the motion. The vote was unanimous.

The budget for 2008 will be \$410.00.

\$60.00 for water master, plus a \$20.00 call out fee.

\$50.00 for secretary and \$300.00 for the work mans compensation insurance.

All water users agreed on the budget and the amount of \$410.00 was adopted for 2008.

Everyone in attendance agreed that if any work needed to be done to any of the ditches all water users must be in agreement on the work and the cost.

A nomination for Garth Monroe for water master was made by Dusty Moore and Lynn Harris seconded the motion. The vote was unanimous.

Water master duties begin 4/15/08 and end 12/01/08.

Water assessment fees must be paid before any water user can use his water.

A nomination for Lynn Harris and Dusty Moore for the advisory committee was made by Garth Monroe and Robin Monroe seconded the motion. The vote was unanimous.

The minutes were read and approved for 2008.
