PRESENT: Troy Foster, Brian Jensen, Lyle Porter, Gale Moser, Regan Wheeler, Eric Frandsen, Maxine Waddoups, and Cindy Bird (Dept of Water Resources).

Lyle Porter was nominated as Chairman; it was moved 2<sup>nd</sup> and passed.

Maxine Waddoups was nominated as Secretary; it was moved 2<sup>nd</sup> and passed.

Credentials committee was appointed as Gale Moser and Brian Jensen.

Troy Foster gave a watermaster report. Discussed last year's budget and water use. He then presented the proposed budget for 2007, which would be the same as 2006. It was proposed to raise the watermaster mileage from \$15.00 a trip to \$16.00 a trip. A motion was made 2<sup>nd</sup> and passed to raise the watermaster mileage to \$16.00 a trip. Discussed the budget for the last 5 years and discussed the minimum assessments. A motion was made to increase the minimum assessment from \$25.00 to \$35.00. This motion was 2<sup>nd</sup> and passed.

It was noted that the County Treasure's office is to still collect the assessments.

Motion was made to hire Troy Foster as River Watermaster on a year round basis, it was 2<sup>nd</sup> and passed. Conan Foster was nominated as assistant watermaster on a year round basis. It was 2<sup>nd</sup> and passed.


Advisory committee was appointed as Brian Jensen and Regan Wheeler.

(Cub River Irr. Co., Preston Whitney Irr. Co., and Preston City.)
