RESOLUTIONS PERTAINING TO THE TIME AND MANNER OF COLLECTING THE BUDGET AS
ADOPTED AT THE ANNUAL MEETING OF THE USERS OF

WATER DISTRICT No. 72F

1st Resolution - Voting of our Water District will be done "one man/decree - one vote" for all policy matters. The money/assessment matters will be voted by "decreed CFS of water."

2nd Resolution - Annual assessment fees are due by December 31st in full. All unpaid accounts will not be able to turn their water on for the following season until balances are paid in full.

3rd Resolution - Our district Budget will be assessed on our actual water decree CFS - until the time measuring devices can be installed on "ALL" diversions in the district, and actual water delivered can be measured.

4th Resolution - The 2006 Budget was unanimously approved as proposed at \$3,300.00.

5th Resolution - Our Annual Meeting date will be the 3rd Wednesday in February.

6th Resolution - Officers & Water Master election - for full year.
