Dear Lawrence;

I have reviewed the spreadsheets that Dawn sent to me recently, and found that they appear to have no connection to the 2007 and 2008 watermaster reports that you submitted in May. The reports seem to show both direct-flow and stored-water deliveries, but shouldn't they just show direct-flow deliveries of rights NOT owned by the reservoir company? I am under the impression, based on recent conversations concerning Fish Creek deliveries, that the delivery of stored water is done by you as an employee of the company/district; if anything, your watermaster report would just show the total storage volume delivered to the company/district if they pay for watermaster services.

Right now I don't know how to get your numbers to balance, so the ball is back in your court.
