I would like to thank all of the Water District Members as a whole for the overall cooperation on the call of water during this last irrigation season. We did work as a team when it counted. Almost everyone did their part. I would also like to thank Earl Worthen, Ron Sorenson and George Montgomery for being there overseeing the water, when I was out of the area

Our members utilized the water earlier, getting the ground moisture up, this was primarily due to excessive water runoff in April, May and the first part of June. On the Land and Marsh Creek drainage side, we did have high water but creeks did maintain within their channels. June 6th was the primary date of the high water mark on Land creek.

The overall previous seasons (2007 & 2008) actual usage has far exceeded the Five Year projections that basically sets up the proposed Budget that we present you with each year. Therefore, some individuals who have not utilized that water quota, does received a sizeable credit going into the next year adjusting what is proposed for the following year. Example of this is in 2007 there was 5157.10cfs / 6203.93cfs and 2008 there was 5304.97cfs / 6732.84cfs. For 2009 a projection of 6024.44cfs is being proposed for the budget, we are hoping that the actual will continue to improve as the last two years that I mentioned. We have so far had very dry snow fall for the majority of this winter versus what we have had in the past. Hopefully the rains will come at the right time to provide the moisture to produce the crops.

I have met with different individuals, had telephone conversations and also met with some of the Starrh Ditch representatives in a meeting setup by Elaine Asher 2/11/09, which I want to thank. I am only sorry that we only ended up with 5 or 6 people. But they did commit the rest that did not show on sharing costs in maintaining the delivery system.

The attached documents pertaining to Head-gates & Measuring Devices in detail along with a map pertaining to the change(s) were sent by certified mail to each individual MCWD Member and I would like to say only one was returned due to wrong address. Since then, it was re-mailed at regular mail. Due to the lateness in getting this information out, a few have made inquiries on why such a short notice! This is primarily from those individuals that did not attend the annual meeting.....(reason)

- It will be noted there was a 37-page document report generated with a detail mapping (12 pages) of the MCWD Delivery System, generated by me and had to duplicate areas for mailing purposes.

I am requesting as your current Water Master, action from this delegation today on the following:

- I am asking for a motion that the secretary, mail out the minutes to each individual member, after each annual meeting, to commence with the 2009 meeting. Also,
- Due to the lateness of information getting to those individuals, that they have an extension in the 2009 irrigation season to complete their task. Also,

I would like to thank those individuals, who have completed or are in the process of completing the tasks that were requested of them.

It will be noted most of the Spring's along the whole mountain frontage of the Water District have yet to reestablish, most are still dry. Amos Creek ran all season (estimated 1.20cfs max to .15cfs min). A spring in the upper portion of Section 24 had a pretty good flow all season.

- The Water District 45F, did accomplish being a separate surface water district from Water District 140. We accomplished this by maintaining an efficient working water district and maintaining proper records and the efforts of a diehard team who believed that it was worthwhile to try and save Marsh Creek Water District 45F. Also, MCWD will not be subject to future assessments from Water District No. 140 for the delivery of surface water provided they continue and maintain good water records.
- We have also been given time to figure out whether we go with our own monitoring of our Deep Wells or let Water District 140 handle the program! Therefore, I feel that at this meeting we need to decide what MCWD is going to do.

One other item of business under ole business is that we agree on a charge for service dealing with Pomerelle Ski Resort, as per discussed in our last meeting. I have formulated my version but have not submitted for review to either the U.S. Forrest Dept. or Pomerelle.

Water Master's 2007/2008
Annual Report

I would like to thank all of the Water District Members as a whole for the overall cooperation on the call of water during this last irrigation season. We did work as a team when it counted. Everybody did there part.

Our over all projection for the season was 5246.23 CFS and our actual usage of water totaled 6203.93 CFS a difference of 957.70 CFS to the good, but short of the actual CFS of the previous year. Which amounted to 118.26%, short of the previous year. Therefore, costing the user less. Our members did utilize water earlier, getting the ground moisture up. Also, due to excessive water run off on the Marsh Creek drainage side we did have a few floods damaging road surfaces in the 900 S and 1050 E. areas. June 6th was the primary date of the flooding. Also,

The trip to the hospital for my emergency surgery, I would like to thank publicly, Ron Sorensen, my mercy driver to the hospital and George Montgomery, Earl Worthen and Ron for handling the water crises during my absents of three days and there support in lifting during my healing process.

Rains came at the right time, extending water into the irrigation season a bit longer especially on the Howell Creek drainage. I did not have to call for the complete first right at the head of Howell Creek as I have in the past. I might also make you aware that the other factor for extending the water season for the third year in a row is the new Rock Dam Reservoir, which the Water District has profited from it.

It will be noted most of the springs (yr 2007) along the whole mountain frontage of the Water District have yet to reestablish, most are still dry. Amos Creek ran all season (estimated 1.20cfs max to .35cfs min).

The Water District 45F, did accomplish being a separate surface water district from the Oakley Water District 140. We accomplished this through the efforts of a few (33 petitioners), who believed that it was worthwhile to try and save Marsh Creek Water District 45F.

- Therefore, the letter received Nov. 24, 2007 referencing Water District 45-F Water Users Petition of Reconsideration to Final Order Creating Water District No. 140; Summary of Meeting and Hearing Held in Albion on October 3, 2007 from David R. Tuthill, Jr. Stated that the letter re-affirms his commitment that his position during his tenure as Director of the Department of IDWR, that Water District 45F will continue to elect its own watermaster and adopt its own annual budget and resolutions for delivery of surface water rights in the Albion-Marsh Creek Basin. Also, Water District No. 45-F will not be subject to future assessments from Water District No. 140 for the delivery of surface water provided they continue maintain good water records.
- We have also been given time to figure out whether we go with our own monitoring of our Deep Wells or let Water District 140 handle it. Therefore,

I am requesting as your current Water Master, action from this delegation today on the following:

1. The consensus after our last meeting with Mr. David Tuthill Jr. and his staff October 3, 2007 at the Albion Firehouse is, do we need a Legal representative for MCWD to continue on with 2008. I have posted funds into the Proposed Budget for the coming year provided you pass it.
2. The Board elected Earl Warthen to represent MCWD at all meetings with Water District 140 dealing in the Ground Water Exercise and Denise Clark was elected the alternate. I believe the two should work together so they are abreast of what is going on. Also,
3. The members of the Water District 45F consider using the Water District No. 140 staff in certifying the wells since the cost is to great for our water district. But to include the regular reading and posting, generating annual reports for the state to the watermaster of 45F, thus eliminating excessive un due cost. The watermaster would not be charging the hourly rate that Water District No. 140 would charge.
4. The Board and members to initiate placing Legal Measuring Devices at all diversions and screw down head gates to be in place by the beginning of irrigating season 2009.

5. Pomerelle Ski Resort to be in place with all their changes with measuring devices dealing with the snowmaking and ponds under the Adjudicated Water rights that was presented to the Watermaster 45F by the beginning of the 2008 Ski season.
6. *In the 2005 annual water meeting, the membership went with \$12.00 a month for the Non-consumptive water User's, leaving the Pomerelle Ski Resort charge still up in the air. Please, I ask you to come up with a specific charge for the Pomerelle Ski Resort. The water usage is very small for the time spent in logging and traveling.*
7. Halord Weir and Diversion was destroyed sometime between the end of irrigation 2006 and the beginning of 2007 irrigation (march 13th the watermaster in turning water out for the Bells found this problem) season. Turned it into the Dept. of Water Resources at that time, have yet to get a report from them. Therefore, I feel it's the responsibility of the Marsh Creek Water District to enforce the law and get this matter corrected.

It will be noted most of the springs (yr 2007) along the whole mountain frontage of the Water District have yet to reestablish, most are still dry. Amos Creek ran all season (estimated 1.20cfs max to .35cfs min).

AREA'S OF CONCERN:

Some of the decreed users have problems with their delivery systems, diversion and measuring devices that are not in line legally. They need corrected so delivery of water can be measured correctly and not estimated. They are as follows:

Marsh Creek Tributary: (main channel)

John Burrows:

Personal Home property:

- A) *'MJ' Diversion screw-down head gate and measuring device required.*

Ben Chatburn Estate (city):

Note: Portions of Property was sold to Fred Darrington and another party. Therefore, with the breaking up of the land with more than one party, will require that they adhere to getting their diversion corrected.

- B) *At 'MK' Diversion a screw-down head gate to be placed prior to weir with measuring device to a pond verses pumping strait from creek at weir. Using a pump from the ponds with a pressure-gage will support what is being handled through hand-lines.*

6S-Ben, Skagg's Ranch:

- C) *'ML' Diversion currently a slide type diversion off of main creek. Therefore, needs Screw down head gate.*

Snodgrass East Side:

- D) *'MM' Diversion has no existing water right at present, but has a Weir and sliding diversion gate with really no existing measuring device.*

Land Creek Channel:

It will be noted that George Kelley is in the process of creating a separate diversion system off of Diversion "LF" and have it enclosed all the way to his point of use. The deliver system would be setup through the 6 S Emory Ranch (South meadows) going east.

Patkin Idaho LLC/Erickson Weir:

- A) *The "LI" Diversion. The weir is in place but there is no Head gate. Setup with sliding boards. Needs screw-down plus a measuring device.*
- B) *Mr. Roger Jenkins needs to open up delivery channel in which he has covered up after purchasing the ground from Cunningham. This is still an issue if Erickson is to use the system.*
- C) *It will be noted that the Cunningham Ranch was sold to Patkin Idaho LLC and the property is being annex into the city of Albion for a new Sub-division.*

6S Ranch/Robinson Weir

- D) 'LJ' Weir needs to be upgraded to a higher height plus screw-down head gate's for both diversions. Robinson needs a corrected measuring gage on his Cipolletti weir, the one that's there is incorrect. 6S has a box w/measuring device, but is a slide type non-lockable device.
- Plus culvert to Marsh Creek needs repaired. A means of a shut off on the Marsh Creek side would prevent pressure build up in culvert during flood stage causing damage to culvert system.

Howell Creek Channel:

Albion Ranch 2006 LLC:

- A) 'HC' diversion was changed to new location (below) but the original is still in tack and is used. They added a new weir and three diversions off of it and I understand they will be enclosed lines with digital measuring devices. This is currently being developed through the new owner of Albion Ranch 2006, LLC. 2007 was the first year of use and the watermaster had to manually take measurements at the weir. This coming season the measuring devices are suppose to be in place. There could be problem areas below this weir since there is no other diversion that I am aware of for the ranch to legally divert water from the creek. They will need to create lateral delivery ditch to handle their water correctly.
- B) Halord Weir and Diversion was destroyed sometime between the end of irrigation 2006 and the beginning of 2007 irrigation (march 13th the watermaster in turning water out for the Bells found this problem) season. Turned it into the Dept. of Water Resources at that time, have yet to get a report from them. Therefore, I feel it's the responsibility of the Marsh Creek Water District to enforce the law and get this matter corrected. In order to deliver water to Jolley, Robinson & 6S Ranch.

Leo/David Bell:

- C) 'HE' diversion has head gate and measuring device, but between head gate and measuring device the ditch needs work done on it. Plus they need to set up a lateral ditch for lower meadows verses taking water at lower part of bank off of creek.

Larry Mahoney:

- D) 'HG' Diversion has screw down head gate needs corrected and no measuring device.

Dayley Diversion:

- E) 'HJ' Diversion, the weir needs maintained, he has a screw down head-gate, but no measuring device. Also, needs a head-gate screw down with measuring device on west delivery system (Goodman Lateral).

Mathews Diversion:

- F) 'HK' Diversion, this need's to be checked out and work done with it. Mathews is talking about utilizing 'HI' diversion, has been okayed by the other parties on the delivery system, but will require a change of diversion and compliance with a measuring device.

Chatburn's 2nd Diversion (south of 800 South 1300 East):

- G) 'HM' Diversion, there is a channel diversion to the east controlled by boards to pond needs a screw down head gate and measuring device.

There is only one other diversions that I am aware of on Howell Creek from this point on to Marsh Creek and that has not been maintained or used for sometime by Chatburn and under the adjudication falls with Geo Kelley.

Brim Creek:

Again, same issue, the main channel does not have any legal diversion and measuring devices on the creek. Due to the adjudication changes, we have delivery of water to David Clark, 6S Ranch and Droz's (others (?)). Their needs to be legal measuring devices and head gates placed on this creek by the users if they are to call for water.

Black Jack Ranch: Larry Mahoney

Rose Creek:

The director's agreement in 2000 with Larry Mahoney was never corrected. There needs to be a main channel weir and diversion head gate with a measuring device, placed at the upper meadow approximately 100 – 150 feet off the fence line. Joe Peterson had been shown where it should be placed and Larry Mahoney is aware.

Broad Hollow Creek:

Larry Mahoney has corrected the problem of water returning to Howell Creek this last spring and was charged for water. He has yet to implement a diversion-measuring device on the creek, the water master is still estimating usage.

Anton / Pine Creek: (Clyde)!!

This is still an on going situation.

The main channel at 1st diversion point Grant Clark (Anton), a diversion screw down head gate needs to be placed with a measuring device(s), needs to be installed. A 2nd diversion placed where Fred Hawker diverts his water with a measuring device(s) head gate needs to also be installed. I have submitted this problem since 2000 when I shut them off.

Pumps in main creek channels! A priority problem on Land Creek is pumps in the creek. This was addressed last year at great length and is still causing a problem in delivering water to the proper right as the creek drops it creates a bigger issue. These pumps have been placed mostly, illegally. The individual(s) have a legal diversion but do not maintain a delivery ditch, but maintain the pump to deliver water for keeping grass green.

I, as the Water master have a problem of controlling and maintaining water usage and or billing, this also infringes on senior water rights.

- The Water District did indicate through Allen Merritt's ruling that if that right is down to a portion of the right and it has to go to the next in line, it is shut off irregardless, if the individual persists to use a pump then there shall be a monitor required instead of guessing on usage. As the Water-master, here are some following options that **SHALL** be implemented. 'ABB C-700 Water Meters vary from the Minimum of ¼ GPM to 25 GPM maximum (3/4" size) to a 1" to 2" sizes that will deal in GPM from ¾ to 2 and max out respectively 25 to 50 GPM. See me for more information.

Marsh Creek channel change, main channel at the Randell Allen residence needs hand on supervision of stream change that was initiated two years ago. ***There needs to be ripe rap done to the creek to complete the project.***

AREA'S Off of Main Channel's:

Marsh Creek Drainage:

- Tom Geary, The West slope drainage needs diversion head gates and measuring device(s) dealing with decreed right 45-02704 and the upper meadows of the west slope.
- A.W. Anderson needs a head gate and measuring device for water diversion off of West slope channel NW of Geary's, only legal water right is off the highland ditch from diversion 'B2'.
- George Montgomery/Kent Cooper diversion 'G' needs an additional measuring device and diversion head gate off of main delivery ditch, placed in valid area for Montgomery's delivery of water.
- Nick & Cedar Knudsen Place needs legal diversion & measuring device w/property transfer off of Vaughn ditch. Decreed Right 45-0312.
- The William Hill (J. O'hare) place on the Vaughn Ditch needs a proper diversion head-gate and measuring device for the decreed right 45F-0312.

- Kent Coopers diversion off of the Vaughn Ditch will require a head gate and measuring device. Also, the delivery ditch fixed up. Water not contained within ditch. (still has a problem)

Howell Creek:

Diversion 'A' (Brim ditch Users) head gate needs repair of seal; Diversion 'B' (Anderson/Hawker/Clark) above weir, main channel repair plus delivery ditch work and partial flume needs leveling;

Cow Gulch Creek:

The diversion and head gate needs work, and the Cipolletti weir needs repair also a measuring device setup off of Asher creek which intermingles with the decreed right off of cow gulch.

Main Marsh/Land & Howell Creek, aka (Narrows):

The main channel weir has completely been repaired by 6S-Ranch. A flow test was done to the main channel weir and the CFS passing through the weir is accurate. The Highland diversion still has to be modified with measurement devices for the delivery system to the two new catch basins that were developed at the Narrows.

Point of Interest:

Six-S Ranch developed a new Reservoir during the 2004 season, completing the project in December 2004. The dam that was constructed is called "Point of Rocks Dam" was constructed to a height of 25+/- feet. The homogenous/zoned earth fill dam provides storage of 253 acre-feet for irrigation, recreation, and fish and wildlife propagation. Although originally designed as a thin core dam, the dam was constructed as a section dam with the upper 2/3 consisting of impervious material and the lower 1/3 of pervious material. The irrigation project services an area consisting of 1,541 irrigable acres under existing distribution systems from Marsh Creek.

The last two seasons, 6S-Ranch's two sediment catch basins (with the following dimensions (225' long, 10' deep, 60' wide) were constructed immediately adjacent to Marsh Creek and 6S-Ranch's property in the SENW of Section 22, Township 11 South, Range 25 East, Cassia County. Only one basin will be in use per season. When the first basin is full of sediment, water will then be diverted into the second basin. Water will be diverted into the sediment catch basin and then immediately returned to Marsh Creek. The purpose of these catch basins is to substantially reduce the amount of sediment and debris in Marsh Creek, thereby improving its water quality. It will be noted that this is working very well and will keep from filling the Reservoir with silt


