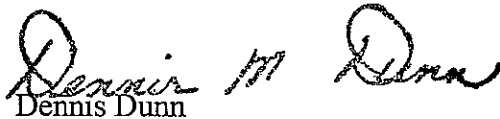

Water District 74Q

The annual meeting for the year 2006 of Water District 74Q was held on March 6, 2006, at 2pm at the Leadore EMT building with three water users present: Rick Snyder, Randy Snyder, Tex Kauer, Blair Kauer, John Amonson and Judy Amonson. In the absence of Chairman, Bill Snyder, Rick Snyder was delegated to conduct the meeting.

Selection of Chairman and Secretary/Treasurer were considered. The consensus was unanimous that the chairman, Bill Snyder and secretary/treasurer, Judy Amonson remain unchanged.

There were no reports from the Credentials Committee consisting of Scott Tyler, John Amonson, Vinn Strupp and Jim Martell. As there was no discussion of any change it was agreed by all present that the present member list remain unchanged.

Compensation to the watermaster and his assistant were reviewed with no changes made. John Amonson made the motion that they remain unchanged. The motion was seconded by Randy Snyder and it was carried.

The minutes of the last years meeting were read and approved by all present.

The proposed budget for 2006 and financial report of 2005 were considered. John Amonson made the motion to adopt the budget for 2006. Randy Snyder seconded the motion and it was carried.

Review of the resolutions were considered. John Amonson proposed an additional resolution be added regarding the watermaster's daily record book. Rick Snyder made the motion that Resolution 2006-1 be added. Blair Kauer seconded the motion and it was carried.

One application for watermaster from Mike Zaharias was presented. Tex Kauer made the motion to hire Mike Zaharias again for watermaster. The consensus was unanimous and it was carried.

Discussion followed regarding the IDWR letter of February 27, 2006, which was read by the secretary, stating the Department of Water Resources receiving inquiries and complaints regarding diversion of water after the irrigation season. Date changes and water issues related to our district were reviewed.

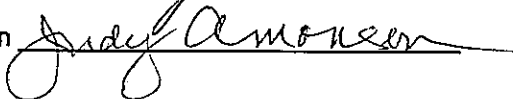
