Water District Annual Meeting 2007  
January 9th, 2007 1:00PM  
Raft River Electric Board Room Malta, Idaho

Nolan Branch opens meeting. Nolan ask for nomanation's for Chairaman. Mike Lewis nomanates Nolan Branch. Rod Jones 2nd the nomanation. All in favor, Nolan Branch stays as Chairaman of water district. It was stated that Dusnip Has now bought land in Bridge, and that they need to be on the list of water users. Jeff Johnson also needs to be on our list. Was noted that U S Geothermal now ownes water right on Raft River with the purchase of the Wilcox farm in bridge. Mike Lewis read the minutes of the 2006 meeting. Mike moved that the minutes be accepted as read. Joyce Ward 2nd.

Dussicison was made by Max Booth that the Reid Stewart's ditch be cleaned as much water was being waisted. Watermaster, Rick Neff explained how and where the water is measured, and the loss is billed to Jim Holmgren. A question was asked as who is responisable to maintain the ditch from Clear Creek to Reid Stewart's pond. Max stated that Reid has cleaned the ditch in the past. Cranny Farms is beleaved to be running the farm agean this year. The watermaster will tell them the ditch needs to be cleaned.

The 2006 Budget was read and accepted by all present. The 2007 Proposed Budget was read and moved by Mike Lewis that the budget be asspted as read. all aproved. A Motion was made by Max Booth to nomanate Jason Warr to replace Reid Stewart as Commitie Member. Mike Lewis moves that the rest of the commity remain the same, all approve. Doug Glaspey of US Geothermal explains the water usege intended for the upcomming Electrial Power Generation plant being built.

Jason Warr brought up the subject of cleaning the Raft River channel going accross the Higley property. This land was flooded last year. Nolan talked about the river flooding last year just north of Perice Lane, onto Kunau's and Gardner's property. Nolan is to check into the procedures of cleaning the channel.

The questions was asked about Reed Springs and the flow rate the past year. A disscusion was made as to the histroy of the flow of Reed Springs. Dusnep, who now owns the property Reed Springs is located on, needs to be informed of the cirtia of recharging Reed Springs.

Rick said he flew up the Raft River from Malta to the Utah state near the end of June. no illegal dervisions were found.

Nolan talked about the proposed ground water district meeting being held on Jan. 17th and the election on Feb. 6th 2007.
