Robin Monroe brought the meeting to order at 1:04 p.m. Monday, March 2, 2009. Water users in attendance this year were Lynn Harris, Dusty Moore, George Harris, Chuck Schvaneveldt, Casey Quinn, Mark Harris, and Garth and Robin Monroe.

A nomination for Robin Monroe for this year's secretary was made by Dusty Moore and Mark Harris seconded the motion. The vote was unanimous.

The budget was reviewed, and the amount of \$410.00 for 2009 was agreed upon. Mark Harris made a motion that we adopt the budget, Garth Monroe seconded the motion, and the budget was adopted.

The water master receiving \$60.00 for the year, with a \$20.00 call out fee.

The secretary receiving \$50.00 for the year.

Work mans compensation insurance \$300.00.

A nomination for Garth Monroe for this year's water master was made by Mark Harris.

Dusty Moore seconded the motion. The vote was unanimous.

Water master duties begin 4/15/09 and end 12/01/09.

All water users agreed that if any work needed to be done to any of the ditches, everyone must be in agreement on the work and the cost. The vote was unanimous for this proposal.

Water assessment fees must be paid before any water user may use his water. The vote was unanimous for this proposal.

All water users are responsible for putting out their own water. The vote was unanimous for this proposal.

A nomination for Wade Harris, Dusty Moore, and Lynn Harris for this year's advisory committee was made by Mark Harris. Robin Monroe seconded the motion. The vote was unanimous.

The minutes were read and approved for 2009.
