Dear Mr. Dopita,

In following up on our conversation of June 3, 2010, I am sending a revised 2010 Assessment Notice for Water District 29-D, a water right change of ownership form for your three water rights and a summary report for irrigation right 29-2224J, currently in the name of Russell Tibbitts.

As we discussed, you should complete an ownership change form for the two domestic ground water rights, 29-11551 (currently listed under the name of George and Ruth Allredge), and 29-11486 (currently listed under the name of Russell Tibbitts). You may use the same form to change the ownership of both rights, as well as right 29-2224J. However, since you use right 29-2224J on both the former Tibbitts and Allredge lots, I suggest you make an appointment with staff at our regional office in Idaho Falls to review the appropriate maps and evaluate if a water right transfer may be needed or desirable in order to more accurately reflect the current place of use for right 29-2224J. You may contact our regional office directly at (208)-525-7161.

Please submit the Water District 29-D invoice in the amount of forty dollars (\$40.00) within 30 days of the date of this notice to the Water District 29-D treasurer at the address listed on the assessment.
