The annual meeting of Water District 75-A was called to order on March 2, 2009 at 1:36 p.m. Those in attendance were Bob Kramer, Ron Austin, Bob Blackadar, Dale Edwards, Jim Austin, Joe Proksch, Ralph Benedict, Harry Shanafelt, Stan Haddock, Jim Juza, and Amy Fealko.

The revised 2007 minutes and 2008 minutes were read and approved. A motion was made by Blackadar and seconded by Jim Juza to approve the minutes. The motion passed unanimously.

### CREDENTIALS AND ADVISORY COMMITTEE

A motion was made by Jim Austin and seconded by Harry Shanafelt that the Credentials and Advisory Committee be as follows: Dale Edwards, Bob Blackadar, Mickey Verbeck, Leo Marshall, Ron Austin, Joe Proksch, and the Arrowhead representative. The motion passed unanimously.

#### BUDGET

Ron Austin made a motion to adopt the same budget as in the 2008-2009 year. The motion was seconded by Harry Shanafelt and passed with unanimous approval. The committee will continue to put approximately \$500 into the contingency account.

- 3) The water master will withhold water until a user's assessment is paid.
- 4) The District will have a water master 12 months of the year.

  A motion was made by Bob Blackadar to accept these resolutions and seconded by Jim Juza.

# WATER MASTERS AND SECRETARY/TREASURER

Harry Shanafelt stated that he would like to resign the position of Summer Water Master. Jim Juza made a motion to appoint Paul Stokes as Summer Water Master and Assistant Winter Water Master and Harry Shanafelt as Summer Assistant Water Master and Winter Water Master. Ron seconded the motion. Bob Blackadar made a motion to retain Amy Fealko to act as Secretary/Treasurer. Jim Juza seconded the motion. Both motions were passed unanimously.

Idaho Arrowhead Water District would like it to be on the record that they oppose a city employee as Water Master. This has been mentioned in prior years and no solution has been found. Bob Blackadar pointed out that the City has the greatest stake in the water as well as the experience to perform the Water Master duties. Jim Juza asked Shanafelt how many diversions are checked, and Shanafelt estimated 10-11 are checked weekly.

## <u>ADDITIONAL BUSINESS</u>

Amy Fealko will check with the County to see if they can include itemized water right information on the bills.

Joe Proksch mentioned that the City is researching water rights. The oldest right in the county is approximately from 1855.

Jim Juza made a motion to adjourn the meeting and it was seconded by Bob Blackadar. The annual meeting was adjourned at 2:05 p.m.
