RESOLUTIONS PERTAINING TO THE TIME AND MANNER OF COLLECTING THE BUDGET AS
ADOPTED AT THE ANNUAL MEETING OF THE USERS OF

WATER DISTRICT No. 11-F

The advisory board was left the same with the exception of Mike Sarton replacing his father Jim Sarton who resigned. The wages for the watermaster and secretary also were left the same at \$1500.00 and \$400.00 respectively.

The budget will be sustained by an assessment of \$11.00 per CFS being charged for all water rights plus a debits and credits system being set up for actual use of the water.

Explanations on how to change the name of the current water user to replace older water users names was explained by the watermaster, Joel Tenschler. Joel Tenschler was retained as watermaster for 2009.

Water measuring devices were then discussed with plans being made to have all points of diversion equipped with measuring devices by 2010. Several are planned for 2009.
