Dear Mr. Peterson;

We have received the minutes of this year's water meeting, and your 2006 Adopted Budget. Oaths of office are enclosed for you and Mary. Once we receive your notarized oaths, your certificates of appointment as watermaster and treasurer for 2006 will be issued.

With regard to the water right of Bruce Price, he has claimed 10" of 37-4026. This was originally 80 inches of water with a 4-1-1885 priority. The full 80" has been claimed by Arlen Crouch, although he did not claim all of the land that could have been irrigated with this right. George Merrill also claimed 2" of this right. The SRBA staff will have to sort this out in their review process, which has not yet been done, so it is impossible at this time to say how much of this right, if any, Mr. Price is entitled to. Printouts of the original right and the SRBA claims are enclosed for your information.
