Re: West Fork Sandy Creek

Dear Mr. McConnagy:

This letter is a follow-up to our conversation last week regarding the delivery of the McNellis water rights from the West Fork of Sandy Creek, specifically the water right(s) associated with the point of diversion located in the NENW Section 4, Township 20N, Range 24E (labeled as point WFS-1 on the attached map).

A review of IDWR records show that water rights 74-200 (McNellis) and 74-7231 (Lemhi Hydropower) are the only rights decreed from the above point of diversion. These two water rights, according to information provided by you, utilize a buried pipeline as a conveyance system. However, I further understand that a ditch diverts from the creek next to the pipeline and that this ditch was the former conveyance for right 74-200. As shown in the attached water rights list, right 74-200 is the most senior priority right on the West Fork Sandy Creek and right 74-7231 is the most junior priority right. You stated last week that the available flow in the creek is not adequate to fill all rights on the creek including right 74-7231.

Mr. McNellis has filed an application for transfer to add the above point of diversion to the remainder of his West Fork Sandy Creek water rights using the pipeline described above. I understand that the transfer application was just filed within the past few weeks and will be advertised this month. Until the application for transfer is approved, water rights 74-200 and 74-7231 are the only rights that should be delivered from this point of diversion. If the available flow of the creek is not adequate to fill all rights, then only the 2 cfs authorized by right 74-200 can be delivered at this point of diversion. The other McNellis rights must be delivered at the appropriate decreed points of diversion as described in the attached water rights listing that are cross referenced with the enclosed map.

Please be advised that there should be a lockable control structure and an approved measuring device at this point of diversion to insure the accurate delivery of these rights. If these do not exist, I would strongly suggest that they be installed as soon as possible to avoid further controversy. I understand that a weir may already exist in the ditch whose heading is next to the pipeline but that the weir may need some basic maintenance. If so, then it may be easier to

deliver right 74-200 to the ditch and measure the water using the existing weir until such time as a measuring device is installed on the pipeline or at the head of the pipeline.

Please also note that a more comprehensive list of water rights for Water District 74-G was developed and sent to all Lemhi Basin area water districts several years ago. The previous watermaster would have received this but it may not have been forwarded on to you. Please advise me if you do not have the more comprehensive list of rights for the water district and we will forward a copy to you for your records.
