Re: Water District 29-D Updated Assessment

Dear Gentlemen,

I have received confirmation that the Pidcock Co. Inc formally abandoned water right no. 29-2511. This right authorized diversion of 0.89 cfs from Green Canyon for irrigation of 65.2 acres. Your abandonment of this right permanently removes it from assessment by Water District 29-D, including the 2010 assessment. This reduces your 2010 assessment by \$136.93. Although you did file a water right transfer to update the place of use and reduce the total irrigated acres under water right 29-2005, the water right diversion rate remained unchanged and therefore does not change the water district assessment of the right. No changes or transfers were made to water right 29-10341.

Please find enclosed an updated 2010 Water District 29-D assessment. The total assessment has been reduced to \$572.32. This revised assessment should be payable to Water District 29-D by August 10, 2010.
