The annual meeting for the year 2008 of Water District 74Q was held on March 3, 2008, at 2pm at the Leadore EMT building with nine water users present: Rick Snyder, Randy Snyder, Scott Tyler, Lucas McCauley, Curtis Beyeler, Tex Kauer, Blair Kauer, John Amonson, Judy Amonson and Helen Harrington, representing the Department of Water Resources. In the absence of Chairman Bill Snyder, Rick Snyder agreed to conduct the meeting.

Selection of Chairman and Secretary/Treasurer was considered. Rick Snyder made the motion that Bill Snyder remain as Chairman and Judy Amonson remain as Secretary/Treasurer. The motion was seconded by Scott Tyler and it was carried.

There were no reports from the Credentials Committee consisting of Scott Tyler, John Amonson, Vinn Strupp and Jim Martell. As there was no discussion of any changes it was agreed by all present that the present member list remain unchanged.

Compensation to the watermaster and his assistant were reviewed. John Amonson made the motion that the compensation remain unchanged. The motion was seconded by Scott Tyler and it was carried.

The minutes of the 2007 annual meeting were read by Rick Snyder and were approved by all present.

The 2008 budget, along with the Watermaster report, proposed budget and financial report were considered. Scott Tyler made the motion to adopt the budget for 2008. The motion was seconded by John Amonson and it was carried.

A discussion followed on resolution number 2006-1. It was decided by all present that an amendment be added stating that the watermaster's daily record books be scanned into a computer and recorded on a CD, with a backup copy. The watermaster will continue to deliver the monthly book to the secretary/treasurer for the recording process at the end of each month. A motion was made that 2008-1 be added to the resolutions stating the above. It was seconded and carried..

There was one application for watermaster. Scott Tyler made the motion that John Amonson be hired for the watermaster job for the 2008 season. The motion was seconded by Randy Snyder and it was carried.

There were no reports from the Advisory Committee consisting of Scott Tyler, Bill Snyder, Tex Kauer and John Amonson. It was agreed by all present that this committee member list remain unchanged. The motion was seconded and it was carried.

Discussions that followed were regarding headgates, water right changes and measuring sticks. Scott Tyler made the motion that John Amonson order a measuring stick with water district funds to facilitate problems of measurements on this creek. Randy Snyder seconded the motion
