On this page, go to the Water Districts Record Search application located about half-way down the page, enter 13A for the water district and 2009 for the year and click the Related Documents button. This will bring up a window showing all related WD13A documents for 2009. The inventory info is the last document on the list - we just scanned all the information into one pdf file. This will give you the option of viewing online but it may be very big to download. If you want a CD with the file we can send that to you as well.

Regarding Maple Creek: Please have Roger complete the oath of office form for deputy watermaster and turn that in to Eastern Region office in Idaho Falls so that they can appoint him as a Deputy or Assistant (it would be preferable to turn in his oath along with yours at the same time). The Regional office will then issue certificates of appointment. You can obtain a copy of oath forms for watermaster, deputy watermaster and district treasurer from our website using the following link:

Roger Wright has agreed to be the assistant Water Master on Maple Creek. He signed the oath and I have sent it in to the Water Resources in Idaho Falls.

I checked on the Franklin Pump diversion and they have a measuring device installed at the diversion point. It is a mag meter. I will get with them when they start using water and make sure it works and we need to make sure it is accurate some how.

I will make contact with Cub River Irragation concerning the middle ditch avfm and see what they are planning to do about this inaccurate measuring device. Matt Weaver told me that it was accurate up to 15 cfs but any higher and it was not accurate.

Preston City told me that they where going to fix the meters that they installed that where not accurate on the Glendale and the Foster Reservoirs. They think that it is very important that we have these water measurements. They have collected money from Preston Whitney and Cub River Irragation as per the agreement with them to have these installed and working properly. All parties agreed to this.
