Dear Bruce;

We have received the minutes of this year's water meeting showing that you have been elected as watermaster of your district for this year. An oath of office is enclosed for your signature; once we receive your notarized oath, a certificate of appointment will be issued.

A daily-record book is also enclosed for your inspection and possible use. While the use of these books is not required, we do expect you to turn in your field delivery records at the end of the year along with your watermaster's report. In order to complete the report properly, you will need to determine the total volume of water that each user received during the delivery season. The delivery cost to each user will then have to be determined based on the actual amount of water each received rather than on just what their recorded water rights are. The law on this changed several years ago, but I have been pretty lax with Mr. Peterson based on the small budget of your district. You can use debits and credits to take care of the cost differences between the adopted budget and actual delivery costs, or you can use a running average with no debits and credits. Feel free to contact me if you have questions. Let me know if you need more daily-record books.

Watermaster training is being scheduled for this spring, and I have asked our Boise office to notify you once the details are finalized.
