RESOLUTIONS PERTAINING TO THE TIME AND MANNER OF COLLECTING THE BUDGET AS
ADOPTED AT THE ANNUAL MEETING OF THE USERS OF

WATER DISTRICT No. 430

"That no ditch or Canal Company, or other water user shall have the right to demand and receive water, and the watermaster shall not deliver to such person until the amount due & payable from such as fixed by the budget, has been paid. Such amounts shall become due and payable 15 days after receipt of water bills, and paid amount, if not paid shall bear interest at the rate of 8% per annum. Also, the water user must present to the watermaster his paid receipt or other proof that his budget has been paid before he can demand water."
