Dear Mr. Runyon;

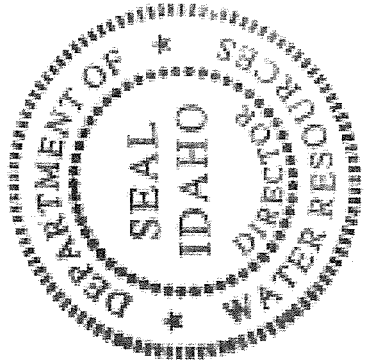
