Note:

Usage is billed to the authorized users at the rate of \$8/stream/day for the streams they actually use. The watermaster is paid to manage those streams at the rate of \$7/stream/day. Deliveries are made on a rotational basis, or as called for if the water flow is sufficient. Once the flow of water in the main channel falls below 4cfs, usage reverts exclusively to the Garden Creek Irrigation Company and the watermaster is no longer needed.

All potential users share the Worker's Comp expense at a flat rate of \$11/user.
