Re: Notice of Public Hearing for Water District 120 Boundary Modification

Dear Water User,

You are receiving this notice because you are listed as the current owner of a water right located within Water District No. 120 (“WD120”) or Water District No. 29O (“WD29O”)¹ or are the owner of a water right proposed to be incorporated within WD120. The Idaho Department of Water Resources (“Department”) is hosting a Public Hearing on the proposed action to modify the boundary of WD120 as described in the enclosed Notice of Public Hearing.

The proposed action would incorporate approximately 200 additional ground water rights into WD120. The proposed action will have little or no effect on assessments for existing ground water diversions in WD120 or WD29O.

At the hearing the Department will present information about the proposal to modify WD120. Persons attending the hearing will have an opportunity to make an oral presentation regarding the proposed action. The Department will consider testimony presented at the hearing and timely submitted written comments to determine whether the proposed modification of WD120 is appropriate.

The Director (“Director”) of the Idaho Department of Water Resources (“Department”) is authorized under Idaho Code §§42-604 and 42-237a.g to divide the state into water districts for the purpose of distributing water among appropriators. Idaho Code §42-604 also authorizes the Director to revise boundaries of existing water districts if such action is required to properly administer uses of the water resource. The authority to revise boundaries of water districts applies to those streams, or other water sources including ground water, for which the priorities of appropriation have been adjudicated by court decree. Idaho Code § 42-226 declares all ground waters in the State of Idaho to be the property of the State, whose duty it is to supervise the appropriation and allotment of the water to those diverting the same for beneficial use.

Surface water and ground water rights in the American Falls area have been adjudicated by the Snake River Basin Adjudication (“SRBA”) District Court. The Department created Water District No. 120 (“WD120”), American Falls Area, in 2002 and modified its boundaries several times between 2004 and 2007. The SRBA was completed on August 25, 2014.

The Eastern Snake Plain Aquifer Groundwater Management Area (“ESPA GWMA”) was designated on November 2, 2016, in response to declining ground water levels in the ESPA, and declining flows in both the Snake River and surface water sources tributary to the Snake River that have been documented since the 1950s. A factor contributing to these declines are ground water withdrawals from within the ESPA GWMA. The ESPA GWMA boundary extends south and east of the current WD120 boundary.

PROPOSED ACTION

The Director proposes to modify WD120 to include an area located between the existing WD120 and the ESPA GWMA boundaries as shown on the map attached to this notice. The proposed modification will incorporate into WD120 all ground water rights in this area that are not currently within a water district. An area encompassing nine ground water rights currently within WD29O (Bannock Creek Drainage) is also being considered for incorporation into WD120 because this area of WD29O is within the ESPA GWMA and the rest of WD29O is not. Ground water rights excluded from administration by WD120 are domestic and stockwater rights as defined in Idaho Code §§ 42-111 and 42-1401A(11), and ground water rights administered by the Shoshone-Bannock Tribes and the United States pursuant to the 1990 Fort Hall Indian Water Rights Agreement.

REASONS FOR PROPOSED ACTION

The Director is statutorily required to divide the state into water districts for the purpose of administration of waters of the state in a manner that protects prior surface and ground water rights. Except for ground water rights in WD29O, ground water rights and diversions in the proposed WD120 modification area are not currently administered by a water district, yet their withdrawals have a depletionary effect on the water resources utilized by senior surface and ground water right holders. Administration of the ground water rights in the proposed WD120 modification area is required to protect senior uses of water from junior water uses in

this portion of the ESPA GWMA. It is most efficient to place these ground water rights in WD120 rather than a separate water district.

NOTICE OF HEARING

Pursuant to Idaho Code § 42-604, the Department will conduct a public hearing regarding the proposed modification of Water District No. 120 as follows:

Information and testimony presented at the hearing on December 9, 2021, will create part of the record upon which the Director will rely to determine whether the proposed modification of WD120 to extend the southeastern boundary is appropriate. It is important that holders of water rights understand the proposed action and participate in the hearing process. The Department will present information at the hearing about why it is proposing to modify WD120. Persons attending the hearing will be provided an opportunity to make an oral presentation regarding the proposed action.

Peter Anderson of the Department will serve as the presiding officer.

The hearing will be held in accordance with the Department's Rules of Procedures (IDAPA 37.01.01). These rules may be viewed at the Idaho Department of Administration's website as follows:


SUBMISSION OF WRITTEN COMMENTS




