The meeting was called to order at 7:00pm by president Diane Park.

15 people attended the meeting.

The minutes for 1998 were read and approved.

### Reports for 1998-1999:

**TREASURER/ACCOUNTANT** Delores LaLiberte was not available so Al Beardslee read the reports she provided for the 1998 Income Statement and the 1999 Proposed Budget

**WATER MASTER** Dan Park reported that we had no trouble reported during the season. Dan's position was activated July 2, 1999 when the Sylte ranch requested water. The water level fell steadily through August. At the end of September the levels began dropping below the 6'4" mark, due to a lack of water coming into the lake, evaporation and seepage. Rainfall was non-existent during that time. Mrs. Curran expressed her concern over the rate of outflow through the channel. The answering explanation regarded many factors, of evaporation, seepage, lack of rainfall, poor watershed due to logging, and drought.

Gordon Sylte reported some concern regarding the logging methods used by Inland Paper in our watershed area. There will be a meeting with the Department of Lands, Inland Paper and the Flood Control District in May. He recommended we send a representative from our Water District, and will call with the time and date.

**OLD BUSINESS:** Gordon Sylte reported that Gus Roth has since sold the land with the sump, therefore it is no longer a problem for Gus.

### **NEW BUSINESS:**

**BUDGET FOR 1999:** The existing budget for fiscal year 1/01/1998 thru 12/31/1998 was reviewed and approved to remain at \$5500 for the fiscal year 01/01/1999 thru 12/31/1999.

Gordon Sylte said that one of the gates at the dam has been damaged, and that they have had RC Worst check out the problem. It is not fixed at this time. They will be making repairs.

Al Beardslee will check on the availability and price of an evaporation gauge for the lake.

A proposal by Terry Moore was made and approved to allow up to \$2000 to be spent towards cleanup of the Rathdrum Creek. Gordon will help co-ordinate a volunteer work crew sometime in June or July to clear the creek of brush and debris and to haul clay to various points where it can be used to muddle the creek.

### **ELECTION OF OFFICERS:**

Ray Moore made a motion that the current officer for President, Diane Park remains the same.

Chet Park nominated Ray Moore for Vice President. He was elected by a majority vote.

Sue Park volunteered and was nominated as Treasurer/Secretary
