# TWIN LAKES WATER DISTRICT #95C ANNUAL MEETING, MAY 19, 2011 7PM TWINLOW CAMP, TWIN LAKES IDAHO MINUTES

The meeting was called to order by Chairman Don Ellis at 7:03 pm. The minutes of the May 17, 2010 annual meeting were approved as written. The minutes of the September 16, 2010 special meeting were approved as written. The treasurer's report (income statement) was presented by Treasurer Sue Park, and then approved.

Watermaster Laurin Scarcello gave the watermaster's report. Laurin also spoke to the need of an assistant to help him get up to speed on his new position. Dan Park was recommended.

Compensation of the watermaster was then discussed at length. This discussion included the standards by which the watermaster is activated. It was moved, by Paul Finman, "that we continue the practice of the last ten years and not pay the watermaster." The motion was seconded, and then discussed. The motion failed. Karen Cooper then moved that, "we compensate the watermaster at \$20. an hour and pay government rate for mileage." Jeff Watkins seconded the motion. After discussion, the motion passed.

Advisory Committee – Steve Kolb, Dan Park and Terry Kiefer were nominated and elected by a unanimous ballot.

The budget (attached) was presented by Treasurer Sue Park/Watermaster Laurin Scarcello. It was noted that the total for watermaster expenses were set at \$2,500. The total tax assessment amount has been lowered again this year – to \$500. The budget was accepted.(Moved by Megan McKinlay; seconded by Mike McKinlay).

Elections – The following slate of officers was nominated, then elected by a unanimous ballot: Don Ellis – chairman, Susie Ellis – secretary, Sue Park – treasurer, Laurin Scarcello – watermaster, and Dan Park – assistant watermaster.

Other Business -

We are now at full pool (about 10.4 to 10.8). It is an hourly watch to see how much we can let out, to lower the high lake level, without flooding someone downstream. We have about 3 feet of snowpack which is a water equivalent of 17."

Gordon Sylte updated us on the Flood Control District. After this year's payment of \$41,000., on the dam, we will owe less than \$100,000. Because the aluminum gates did not hold up well to vibrations, and neither the engineer or the manufacturer would take responsibility, the FCD had to spend about \$12,000. That \$ provided new supports on the two outside gates, and replaced the middle gate with a stainless steel one. The gear boxes and relays also had to be replaced because they froze. The FCD is looking for a better cover for them.

North Idaho Adjudication – They are continuing to process the applications that they have received.

The next annual meeting will be the second Thursday in May 2012.
