WATER DISTRICT 74-W MEETING MINUTES

Chairman Kurt Bird called the annual meeting of Water District 74-W to order at 1:05 P.M. at the Leadore City Community Building, with Thirteen members or representatives in attendance.

Chairman Bird asked for the reading of the 2012 minutes by Secretary Aleta Ries. Carl Ellsworth moved to amend the minutes to include equipment rental of \$800.00 to be paid monthly. Blair Kauer moved to accept the minutes as amended, Laura Foster seconded, so carried.

NEW BUSINESS

FINANCIAL: Chairman Bird asked for the financial report. Treasurer Ries reported that the district has -\$51.52 balance in the checking account as of March 4, 2013. There is no outstanding water bills. Ray Kagel paid past due amount of \$86.85 on June 4, 2012, \$12.28 interest for a total of \$99.13 \$289.00 was paid to the State Insurance Fund for 2012. The State Insurance Fund billing for 2013 has not arrived. It is due April 1, 2013. No interest earned on checking.

ADVISORY BOARD: Chairman Bird called for nominations to be opened to elect advisory board. Blair Kauer stated he was resigning due to he is no longer affiliated with Mcfarland Livestock. Motion was made by Carl Ellsworth to retain James Whittaker and Merrill Beyeler and appoint Thayne Kauer. Allan Purcell seconded. So carried by unanimous vote.

CREDENTIAL COMMITTEE: Carl Ellsworth made a motion to retain the Credential board, consisting of James Whittaker, Merrill Beyeler and to appoint Thayne Kauer to the Credential Committee. Allan Purcell seconded, so carried.

INTEREST: Carl Ellsworth moved to retain the current interest rate of 10% on unpaid water monies. Merrill Beyeler seconded, motioned carried by a unanimous vote.

RESOLUTIONS: No additions, No changes.

BUDGET: The budget for 2013 season was proposed at \$15,122.63. Merrill Beyeler motioned to accept the proposed budget with the agreement beginning the next season of 2014 to discontinue the debit/credit adjustment and budget for 7months. Carl Ellsworth seconded, so carried.

WATER MASTER: Dan and Kelly Smith and Debora Tucker were applicants for the water master position. A vote was taken from the present members for the position of Water Master by writing the name of their choice. The Credential Committee collected and counted the votes. Six votes were for Dan and Kelly Smith and two votes were for Debora Tucker. Dan and Kelly Smith were elected to be Water Master for the 2013 season.

CHAIRMAN AND SECRETARY/TREASURER: Merrill Beyeler motioned to retain Kurt Bird as Chairman of Water District 74-W and retain Aleta Ries as Secretary/Treasurer, Carl Ellsworth seconded. Motion was carried.

FIXED WAGES FOR WATER MASTER AND SECRETARY/TREASURER: Carl Ellsworth Motioned to keep water masters wages the same, That being \$350.00 a month and his assistant will receive \$250.00 a month. Additional \$200.00 to be added to the water masters salary for measurements of the heat of the day when necessary. Equipment Rental shall be \$800.00 a month. Secretary/Treasurer Aleta Ries to retain the same pay of \$400.00 per year a total of \$350.00 plus \$50.00 for telephone and postage. Carl Ellsworth seconded, so carried.

OLD BUSINESS

Having concluded all business of Water District 74-W, Chairman Bird adjourned the meeting at 2:31 P.M.
