MINUTES OF ANNUAL MEETING

WATER DISTRICT 75D

MARCH 3 2014

The annual meeting of Water District 75D was held at the Carmen Hall at Carmen Idaho on Monday March 3, 2014 at 1:30 p.m. Dave McFarland was elected chairman for the meeting. Secretary Treasurer for 2014 season will be Kevin Keller.

It was proposed and approved to donate \$60.00 to County Treasurer for billing expenses.

Compensation for Watermaster was set at \$1600 and expenses at \$400 for 2014.

The 2013 Watermaster's report and 2014 proposed budget were presented and approved as follows;

Brian Keller was nominated and unanimously elected Watermaster for the 2014 season. Dave McFarland was nominated and unanimously elected as assistant to the watermaster.

The Watermaster services will start by petition for services and end October 31/2014.

Compensation will be paid when Sec/Treasurer receives the 2014 Watermaster's report and 2015 proposed budget. The amount budgeted to 75D water users are due and payable at the County Treasurer's office on June 20, 2014 to coincide with collection of second half property taxes. 8% interest will be charged on delinquent water user accounts.

Jack Ellis requested to be removed from the advisory board.

Bill Slavin, Bruce McFarland, and John burns were elected to serve on the advisory board for 2014 season, they will advise the Watermaster. Disputes will be brought before the advisory board.

The annual water meeting date for 2015 will be the first Monday in March, notified by the IDWR.
