

Devin Boehme took charge of the meeting. He had the water master Joel Teuscher pass out paper work that has the 2014 – 2015 water assessments for each shareholder. Secretary James Teuscher passed out the Agenda to those present. The secretary then read the minutes from the previous held meeting. The motion was made to accept the minutes by Garth Boehme and seconded by Lon Tueller.

Elections were held for two positions on the advisory board. Garth made the motion to retain the two individuals for another term. Seconded by Richard Leortscher.

Water master position was next for a vote. Motion was made by garth to retain Joel Teuscher as the water master for 2015. Seconded by Richard Leortscher.

Secretary position was next for a vote. Garth made the motion to keep James Teuscher as the secretary for 2015. Seconded by Richard L.

Joel was asked by Devin to go over the 2014 yearly report.

- The water rights for Garth have been split.
- Joel talked to the Senator and Representative from our area about the water adjudication of the Bear River drainage.
 - Reported that it was postponed for 2015
 - Tributaries of the Bear River such as 11F are for the adjudication.
 - The Bear River guys are not for it.
 - Wells are not decreed but are only licensed. Adjudication may help.

Robert Boehme asked if the court in the adjudication would use the date the well was drilled. Joel reported that most of the wells were drilled in the early to mid-sixties.

The Water Master went over the 2015 budget. Reporting was changed from CFM to Acre feet. The Water Master made it clear that the measuring devises need to be operating before the water is allowed to be used. It would be easier to figure water usage if they were working. Stephen & Larsen water rights are split into two. Peggy Tueller has a little and the Boehme's have the rest. Ken Rigby moved two CFMs from the S&L to the Thomas Fork.

Jon C called and talked to the water master about the Price water allotments. They need some attention.

The 2015 budget was gone over. Joel reported that half the budget revenues were from water use and the other was from water share allotments.

The motion was made to accept the 2015 budget by Lon Tueller, and seconded by Garth Boehme. It was voted on by those shareholders present at the meeting.

The motion was made to adjourn the meeting by Lon Tueller and seconded by Kelly Brooks. The meeting ended.

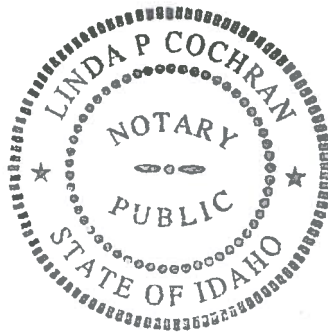
