It was proposed and approved to donate \$5/water user to County Treasurer for billing expenses.

It was Proposed and adopted to increase base fee from \$20 to \$25.

Compensation for Watermaster was set at \$1600 and expenses at \$400 for 2015.

The 2014 Watermaster's report and 2015 proposed budget were presented and approved as follows;
