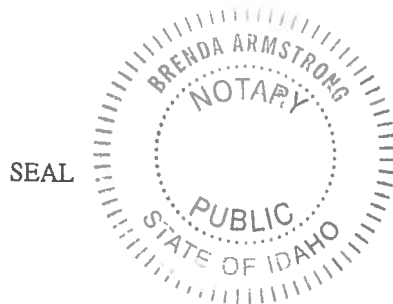

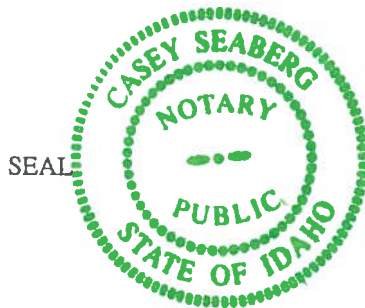

The annual meeting of Water District 75D was held at the Carmen Hall at Carmen Idaho on Monday March 2, 2015 at 1:30 p.m. Dave McFarland was elected chairman for the meeting. Secretary Treasurer for 2015 season will be Kevin Keller.

It was proposed and approved to donate \$5/water user to County Treasurer for billing expenses.

It was Proposed and adopted to increase base fee from \$20 to \$25.

Compensation for Watermaster was set at \$1600 and expenses at \$400 for 2015.

The 2014 Watermaster's report and 2015 proposed budget were presented and approved as follows;

Watermaster's Compensation	\$ 1600.00
Watermaster's expense	400.00
Watermaster's Social Security Tax	264.00
Watermaster's Workman's Comp. Ins.	300.00
Office Expense	200.00
Lemhi County Treasurer	128.00 (an additional \$197 will be donated using existing funds to equal the \$5 donation/water user)
Total	2892.00

Brian Keller was nominated and unanimously elected Watermaster for the 2015 season. John Burns was nominated and unanimously elected as uncompensated assistant to the watermaster.

The Watermaster services will start by petition for services and end October 31/2015.

Compensation will be paid when Sec/Treasurer receives the 2015 Watermaster's report and 2016 proposed budget. The amount budgeted to 75D water users are due and payable at the County Treasurer's office on June 20, 2015 to coincide with collection of second half property taxes. 8% interest will be charged on delinquent water user accounts.

Bill Slavin, Bruce McFarland, and John burns were elected to serve on the advisory board for 2015 season, they will advise the Watermaster. Disputes will be brought before the advisory board. Board is not to advise the assistant watermaster.

Water district 75D formation was thought to have been formed on or around 1905.

The annual water meeting date for 2016 will be the first Monday in March, notified by the IDWR.
