Advisory Board members present: Craig Crandall (President). Jim Andrus, Bryon Allan, Randy Morris, Mark Bennett sitting in for Tom Barnes, Wayne Avery (Secretary).

Craig Crandall called the meeting to order at 2:00 P.M., and welcomed all those attending and introduced his self, and the other board members. He reminded everyone to be sure and sign the roll that was being passed around and put the organization they represented or the stream their water rights were on.

Craig asked for the Secretary to read the minutes of March 3, 2014, Craig also asked if there were any corrections to the minutes that needed to be made. There was none, asked for a motion to accept the minutes, Bryon Allan made the motion to accept the minutes as read. Darwin Josephson second it, motion passed.

Craig then asked for the finical statement to be read, asked if there was any discussion, none followed. Asked for a motion to accept finical statement, Steve Gravis made the motion to accept finical statement as read Darwin Josephson second it, motion passed.

Craig asked that Jim Andrus, Randy Morris, and Wayne Avery serve on the credentials committee and they will use the 2014 irrigation share or water used to vote. Randy Morris made the motion, Mark Bennett second it, motion passed.

Craig went over the proposed budget that Steve Hebdon turned in and it was amended to \$43,065.23. Craig called for a motion to accept the amended budget, Steve Gravis made the motion to accept the amended budget, Jim Andrus second it, motion passed.

Craig stated that the board recommends Steve Hebdon to be hired as water master for 2015 water season, with a wage of \$16,000.00 and expenses to be \$10,000.00, with Linda Hebdon and Kevin Hebdon to serve as assistant water master at no extra cost to the River District and not hire Steve Hebdon for a 3rd year as we have in the previous years, Earl Smith made the motion and Brett Casperson second it, motion passed.

Craig stated that the board recommends to round water assessment to nearest dollar and not use credit and debit system of billing. Bryon Allan made the motion to accept motion and Steve Gravis second it, motion passed.

Craig said that the board recommends using resolution B for collection and use 2014 water figures for billing in 2015 year. Candy Symons made the motion, Randy Morris second it, motion passed.

Craig asked for the election of the advisory board, Steve Gravis made a motion to leave the board as it is currently. Candy Symons second it, motion passed.
