#### WAGES FOR WATER MASTER AND SECRETARY/TREASURER

Water Master will be paid \$300 at the beginning of the irrigation season and \$650 at the end of the season after the "Water Master's Report" is turned in. The Secretary/Treasurer is to be paid \$75.00 for the year. Motion made by Gordon Flinders with a second by DeAnn Rasmussen. All voted in favor.

#### **RESOLUTION E**

Change the date that assessments are due from June 1st to April 1st.

David Matthews will be the water master. Motion made by John Rowley with a second by Daryl Sleight. All voted in favor.

#### ADVISORY COMMITTEE

Daryl Sleight made a motion with a second from Gordon Flinders that the Presidents of the Relief Canal, Southfield Ditch, and Dry Lake Canal will be the Advisory committee. Motion carried.

### **OTHER BUSINESS**

Daryl Sleight is concerned about flooding during the spring runoff where the first creek separates into the second creek. There was work done at this spot several years ago so that during low water the majority of the water would flow down the second creek to supply a water user lower on the creek. Daryl would like a head gate installed to control the amount of water that can go into the second creek during run off

John Rowley ask about run off water that comes down the main canyon and runs over the road and through the Fuch Ditch onto private property. He will ask the County about installing a larger culvert so that the water will not flood the road.

The meeting adjourned at 2:20 P.M. on a motion by Reed Sleight with a second from John Rowley. Motion carried.
