Water master compensation was set at \$400 for expenses and \$1600 salary for the 2017 season.

The Water master's report and 2017 budget were presented and approved as follows:

Brian Keller was elected as Water master for the 2017 season. John Mihalka was elected as water master's assistant., to be paid from water master's salary.

Water master services begin by petition for services and ends October 31, 2017. The petition paperwork is completed at the time the minutes are mailed to the state, but the water master begins providing services when contacted by water users or when the need arises.

Compensation will be paid when the sec/treasurer receives the 2017 Water master's report and the 2018 proposed budget. The amount billed to water users is due and payable at the county treasurer's office on June 20, 2017, to coincide with the collection of the second half of property takes. 8% interest will be charged on delinquent user accounts.

Bill Slavin, Bruce McFarland and John Burns were elected to serve on the advisory board. For the 2017 season. They will advise the water master. Disputes will be brought before the board.

The 2018 meeting will be the first Monday in March. March 05, 2018.

There was discussion about measuring recharge, to gather information to increase our knowledge about the effects from changes in irrigation practices.
