Annual Water Meeting Minutes February 16, 2018

The meeting began, and Zac Cox read the minutes from last years meeting.

The current account balance was reported of \$5351.48. A budget was adopted as follows. Water Master \$500.00, North ditch rider \$75.00, South Ditch Rider \$75.00, Bar-Z \$50.00.

We discussed that it is the responsibility of the shareholder to make sure that their ditches are cleaned from their point of diversion.

It was brought to attention by Allan Hatch that over the last couple of years someone has been deliberately shutting off his water to livestock. One year it was 68 head of cattle, the other it was 45 pair of beef cattle with out water for four of days and this past year it was 120 cows without water for 3 days. As a result, they broke the fence and went through the neighbor's hay fields that were ready to cut. This cannot happen! If this should happen again to Allen Hatch or anyone for that matter the state will be contacted, damages will be compensated, and their water turn will be lost for the remainder of the year. If it is not your turn for the water DO NOT TOUCH IT!

Next year's meeting will be February 16, 2019 at the Clifton Community Center at 7:00 pm.

Meeting was adjourned at 8:30 and seconded by all.
