Annual Water Meeting

March 6, 2018

District 74-A Geertson Creek



The annual water meeting was called to order at the Brooklyn Annex 4-H room on March 6th, 2018 at 7:00 pm. Those in attendance were: Brain Adams, Kathy Adams, Bert Jeffries, Rikka Jeffries, Rockie Walker, Leanne Walker, Sarah Leon, Verdell Olson, Valerie Olson, Nathan Stokes & Cindy Yenter (IDWR).

The meeting was called to order by Bert, and Cindy introduced herself. Last year's minutes were read by Valerie, there were no corrections of the minutes. Valerie passed out a copy of the profit & loss sheet to all members. She proposed that we have a small fee increase on the water tax, as we are spending more than taking in. The fee increase would be a 10% increase of all water users. A copy of last year's fee and a comparison with the new fee was given to all water users. Verdell motioned to go forward with the increase and Brian seconded.

Bert passed out a "repair request to ditch owners" sheet to all in attendance that was created by Rockie. Bert than read each request and it was agreed by Cindy that all listed repairs were legitimate. Bert said all repairs needed to be addressed & fixed before water could be turned to that user. Rikka seconded this motion.

Cindy than spoke to the members about some important issues, such as insurance, legal entities & new rights with water laws. She said our district was doing a good job and covering all areas that are required by the water department.

Nominations then took place for Chairman, Verdell nominated Bert and was seconded by Brian. Brian nominated Valerie for secretary, this was seconded by Rikka. Rikka nominated Rockie to continue as water master & Sarah seconded.

The district thanked Rockie for doing such a great job & making himself available when needed.

Water Master Repair Request to ditch owners "2018"

Tonsmeire - Ditch above weir need cleaned & low spot built up to stop water from leaking out of ditch.

Water is under cutting bank at diversion, needs to be put under pressure.

<u>Vergil Olson – Tree growing around weir needs removed so water levels can be checked. Weir is out of level side to side.</u>

Verdell Olson - Shaved Weir is leaking under structure.

<u>Boyd Stokes – Upper Ranch – Diversion head gate needs replaced & weir needs to be in a flatter area for more accurate measurement.</u>

Sara Leon – Weir needs leveled above Boyd's lower diversion

Gulch head gate needs repaired and weir rebuilt.

Martin Ranch – Weir by haystack across the creek is grown in by trees and needs repaired, water is leaking underneath it.

All plugs on the creek need cleaned out so that the water stays in the creek for all water users.
