Devin Boehme call the meeting to order. The agenda was presented to the shareholders to be accepted. The motion was made to accept the agenda by Garth Boehme. It was seconded by Ron Roberts. Motion passed.

The minutes from 2018 meeting were read by secretary (James Teuscher). The motion to accept the 2018 meeting minutes was by Garth B and seconded by Wyatt R. Motion Carried.

The election was next. The motion was made to retain the current water master and secretary from 2018. Motion made by Garth for Water master and seconded by Wyatt R. Motion Carried. Motion for secretary made by Garth and seconded by Ron R. Motion carried.

The advisory board elections,

The motion was made to retain as is. The second by Wyatt. The motion carried.

The yearly report by the water master. Joel went over the past year. He stated that most of the water rights have been updated. The water per share of water was raised from \$10.00 to \$12.00 for year 2019. Joel asked the Circle B to come and meet the shareholders. Circle B would help with the electronic metering devices.

Joel stated that the adjudication of water is coming in the next couple of years. The older rights are fairly ok because they went through the 1902 lawsuit. They are decreed. It is the junior rights that could be impacted.

Joel talked about the Rasmussen rights. He told Wyatt that they have a metering device but it may not be working. If Wyatt feels like they are using less than is reported than he can talk to Joel after the meeting.

Joel went over the estimated revenue for 2019. He went over the debit and credit of the income. Joel reported that it cost 10 cents more 2018 to deliver the water. Joel also stated that half the assessment was from ownership of the rights. The other half comes from the use of the water throughout the year. Wyatt asked about the 2018 Debit. Joel explained that the water is billed out at \$.15 but it cost \$.47 to deliver therefore the cause for the debit in 2019. It was asked to send the shareholder not present at the meeting the papers showing the 2019 billings. Joel stated that even though the devices are the responsibility of the shareholder, the district may have to cover up front some of the cost of repairing the devices. Then the district will bill the shareholders. Joel stated that when the shareholders open up or closes the head gates, write down the dates or call him.

Joel went to Idaho Falls to IDWR to help him figure out what rights were moved in 2018. Garth asked how many miles the water master drive each week. Tim Teuscher stated that it averages out to be 50 miles/week.

Devin went over the budget for 2019. James stated that the bank balance at 12/31/2018 was at \$9,746.08. Garth moved to raise the water master pay to \$3000.00 in 2019 from \$2500.00 in 2018. Ronnie R. 2nd the motion. There was a discussion on the motion. Rodney asked about the travel money.

What was the travel money used for & how. The secretary stated that the travel money was used for the water master to go up to IDWR in Idaho Falls and to go around the valley to measure record the measurements at the devices. It could be used by the advisory board for similar activities. It would help pay for professionals to come work or present at the meetings. It is not part of water masters wages. If the travel money is not used it remains in the fund. The vote was called for in the respect of the motion to raise the water master pay to \$3000.00. The motion carried with one no vote. Rodney stated he wanted to be on record of his no vote. Motion was made to approve the budget 2019 with the increase of pay for the water master by Garth and seconded by Wyatt. Motion carried.

Motion made to close the meeting by Derek and 2nd by Garth. Meeting adjourned.
