ANNUAL WATER USERS MEETING BIRCH CREEK WATER DISTRICT #32-D

The Birch Creek Water District 32-D Water Users meeting was held March 12, 2019, 10:00 a.m. at the Clark County Annex Building, Dubois Idaho.

Chairman, Mac Wagoner, called the meeting to order at 10:00 a.m.

Those attending were: Greg Shenton (Watermaster), Brett Murdock (Deputy Watermaster), Mac Wagoner (Chairman), Lane Newman, Andy Wagoner, Scott Stosich (IDWR), Jared Adamson (IDWR) and Laurie Small (secretary).

Minutes were read individually. Lane Newman made a motion to accept the previous year's minutes. Andy Wagoner seconded the motion. Motion passed.

NOMINATIONS FOR CHAIRMAN & SECRETARY:

Chairman, Mac Wagoner, asked for nominations for Chairman and Secretary. Lane Newman made a motion that Mac Wagoner continue as Chairman and Laurie Small continue as Secretary. Andy Wagoner seconded the motion. Motion passed.

APPOINTMENT OF CREDENTIALS COMMITTEE:

Chairman, Mac Wagoner, waived appointing a Credentials Committee at this time. If they are needed later, they can be appointed then.

WATERMASTERS REPORT:

Watermaster, Greg Shenton, presented the Watermaster's Report for the year 2018. The 2018 diverted flows totaled 16,442 A.F. down 316 A.F. from previous years diverted and recorded flows. Snow course measurements were 119% of average at Meadow Lake with 65" of depth and 13.5 % water content, 108% of average at Beagle Springs with 34" inches of depth and 6.8% water content, 124% of average at Haun with 31.7" of depth and 5.75% water content and 105% of average at Spring Mountain Canyon with 49.4" inches of depth and 11.4% water content. Snow measurements taken on February 28, 2019.

Measurements on stream bed losses taken by contract with U.S.G.S. between the reaches of Blue Done Weir to the Birch Creek Power Hydro Pond were included in the report. The U.S.G.S. will no longer match funds with the water district on these measurements so there will only be 2 measurements done to keep budget costs the same. The weirs on both ends of this reach gives a very accurate measurement of the total reach if the weirs are properly maintained along with annual silt removal.

Mr. Shenton reported the cloud seeding continues in the area. February 2019 produced good storm patterns for cloud seeding.

The flooding in March of 2018 caused considerable damage to the creek. Waterusers and the Bureau of Reclamation worked together on repairing some of the damage.

PROPOSED AND ADOPTED BUDGET FOR 2019:

Lane Newman made a motion to accept the Watermaster's Report and approve proposed budget. Andy Wagoner seconded the motion. Motion passed.

NOMINATION FOR WATERMASTER:

Lane Newman made the motion to have Greg Shenton continue as Watermaster and Brett Murdock as Deputy Watermaster. Andy Wagoner seconded the motion. Motion passed.

RESOLUTIONS

Lane Newman made a motion that the Water District adopts the following resolutions with the change to the USGS measurements from 3 measurements to 2 measurements a year.

COLLECTION OF WATER ASSESSMENT

No ditch, canal, or other water user shall have the right to demand and receive water until full payment due is paid. Payment shall become due April 15, and shall become delinquent May 15, and if not paid by

May 15, the payment shall bear interest from April 15, at the rate of eight percent (8%) per annum.

The Watermaster shall not deliver any water until full payment due is paid.

WATERMASTER TERM OF SERVICE

The Watermaster shall be elected for a term of one full year. The purpose is so the Watermaster can serve in the legal capacity to do official business for the district in the event of emergencies, legislative actions, hearings, disputes or other water related or job-related activities. The Watermaster cannot be required to make deliveries before April 1, or after November 1, (the normal irrigation season) unless an emergency exists. The Watermaster shall not be paid before April 15, or after November 1, from the Water District budgeted regular funds.

HEADGATES & WEIRS

All control devices and measuring devices shall be in good working order before water can be demanded or delivered. The Watermaster shall not deliver any water unless such devices are in good working order.

USGS MEASUREMENTS

They agreed to continue with the 2 USGS measurement and it was included in the resolution motion.

WATER DELIVERY

Allow Brandie Terry, Scott Bridges, and Mrs. Sorenson to receive water for their lawns, with no daily records require, at no cost to them until any future changes are made.

Andy Wagoner seconded the motion. All 5 resolutions passed.

APPOINTMENT OF ADVISORY BOARD:

Chairman, Mac Wagoner, appointed the following to serve on the advisory board this year. Lewis Newman, Lane Newman, Andy Wagoner and James Palmer representing Ted Sorenson.

OTHER BUSINESS:

The Watermaster reported on cloud seeding being done in the area and handed out a map to review the generator placement, target area and flight lines.

Record flooding beginning March 22, 2018 in Birch Creek was discussed. With the snowfall the second week of March and then warm weather and rain the run off was excessive.

IDWR REPORT:

Scott Stosich and Jarod Adamson from IDWR were in attendance. They did not have a report but asked for any questions. Lane Newman asked for updates on the wells that are being monitored for the recharge program. Mr. Stosich reported the levels are steadily increasing which helps the level of recharge efforts. Mr. Adamson reported that additional sights are being monitored for future data.

MEETING TIME:

Mac Wagoner asked for suggested dates for the next meeting. Lane Newman moved that the annual water meeting for next year be held Tuesday, March 10, 2020, at 10:00 a.m. at the Clark County Annex Building. Andy Wagoner seconded the motion. Motion passed.

Andy Wagoner moved to adjourn at 10:37 a.m. Lane Newman seconded. Meeting was adjourned.
