RESOLUTIONS PERTAINING TO THE TIME AND MANNER OF COLLECTING THE BUDGET AS
ADOPTED AT THE ANNUAL MEETING OF THE USERS OF

WATER DISTRICT No. 74B

The water meeting for Kirtley Creek 74B was called to order by Mona Cockrell on March 11, 2019 at the home of LaMar Cockrell. The minutes from the previous meeting were read and Raymond Cockrell moved to approve them with Steve Herbst seconding it, carried unanimously. A discussion was held to increase the budget for water master by 300⁰⁰ for prokata users from \$500⁰⁰ to 800⁰⁰ including other expenses such as workmans comp. etc. The secretary treasurer will also receive an increase of 10⁰⁰ from 20⁰⁰ to 30⁰⁰ per water user. Minimum water users will pay 20⁰⁰ each plus 30⁰⁰ for the secretary-treasurer fee. Steve Herbst moved to approve this new budget with Orle Cockrell seconding it. Motion carried unanimously. Tom Cockrell moved to retain LaMar Cockrell for water master & Mona Cockrell for secretary-treasurer with Raymond Cockrell seconding it. Motion carried unanimously. Next years meeting will be 2nd Monday in March at 7:00 pm. at the LaMar Cockrell residence. Those attending Orle Cockrell, Steve Herbst, Duane ^{Wright} Kent Harris, Raymond Cockrell, Charlie Cockrell, LaMar, Mona & Tom Cockrell.
