2013 proposed budget presented

A legal and accounting item was added for 2013

Number of diversions in 140 outside sub-districts cut to 213

Slight increase to total budget to \$79,475

Talked about emergency fund

Cindy Yenter wants to know how budget is distributed

Don said it is not necessary because all similar budgets don't change

Corbin asked if the itemized is good enough.

Statute says assessment is by AF only

Advisory board wants to keep the current method of assessment

Corbin said the statute says 5 yrs is not necessary can use 1-5 years as average

Cindy said she estimates the usage in some cases

Randy said advisory aggreed to accept resolution #5 as written then use AF only for next year Randy Brown motion to accept proposed resolutions

Time turned over to watermaster

Brian talks about summary sheets

Discussion about those who have no mitigation outside of a sub-district

Brian introduced Dean Stevenson from magic valley GWD to talk about how they will handle those acres that need mitigation

Dean reviews past efforts to acquire mitigation

If you have irrigation right and need mitigation you will be annexed into the district and pay four year back assessments for MVGWD

No mitigation only members for irrigation rights

Municipal and commercial will be mitigation only

Dean mentions Rangen call possible in the future

Cost per acre will be about \$12-13 per acre up front

Cindy brings up the issue of WWC measuring and reporting for Magic Valley and being watermaster of 140

Time turned over to department staff

Corbin Knowles gives update on new flowmeters

343 wells with meters (irrigation) 144 wells not used or waived from measurement, 100 commercial that have meters, about 625 total

About 75% compliance

Hopefully in 2014 forward district will be completely metered

Meter requirement will not go away.

Battery vs hardwire mentioned

More meters are approved this year

There are a few ultrasonic flowmeters on the list, but they are not recommended

Time turned to Cindy Yenter

Department is going to focus more on water bank leases/uses

Letters will go out for those who do not have mitigation

Could be extra curtailment work this summer if a curtailment is issued

Spring purchases have been seamless

There have been various awep projects including Hazelton Butte

Don Pickett asks about ESPA expanding boundary, Cindy doesn't have any information
