On June 13, 2011, this Court entered an *Order* in the above-captioned matter granting the State of Idaho's *Motion for Interim Administration* of water rights in Basin 75 for those water rights located in Water District 75A ("*Order*"). With respect to the water rights located in Water District 75A, except those held by the City of Salmon, the Arrowhead Water District, or by Edgar and/or Myrtle Edwards, the *Order* authorized the distribution of water pursuant to chapter 6, title 42, Idaho Code, in accordance with the *Director's Reports* and the *Partial Decrees* that supersede the *Director's Reports* issued in the Snake River Basin Adjudication in IDWR Basin 75 for those water rights.

The exceptions made for the water rights held by the City of Salmon, the Arrowhead Water District and the Edwards in Water District 75A were the result of pending litigation between those parties in the SRBA, and certain objections filed to the State's *Motion for Interim Administration* as a result of that litigation. Since the issuance of the *Order*, the litigation between the City of Salmon, the Arrowhead Water District and the Edwards has been resolved and *Partial Decrees* have been issued. Therefore, the exceptions set forth in the *Order* are no longer necessary. This Court issued a *Notice of Court's Intent to Issue Amended Order Granting State of Idaho's Motion for Order of Interim Administration in IDWR Basin 75 for Those Water*



Rights Located in Water District 75A on October 16, 2012. The *Notice* set forth the Court's intent to issue an *Amended Order* reflecting that all water rights in Water District 75A be administered in accordance with the *Director's Reports* and the *Partial Decrees* that supersede the *Director's Reports* in IDWR Basin 75. The hearing on the *Notice of Court's Intent* was held on November 20, 2012, and no objections were filed.

Therefore, IT IS HEREBY ORDERED that the Court's June 13, 2011, *Order* is hereby amended to authorize, without exception, the distribution of water pursuant to chapter 6, title 42, Idaho Code in accordance with the *Director's Reports* and the *Partial Decrees* that supersede the *Director's Reports* in IDWR Basin 75 for those water rights located in Water District 75A.


