RE: Meeting of Water District 34 Groundwater Users to Discuss Conjunctive Management

Dear Water User:

This letter is being sent to holders of groundwater rights that are to be conjunctively managed pursuant to Rule 50 of the Idaho Department of Water Resources Water Distribution Rules - Water District 34 (IDAPA 37.03.13 hereafter, Rule 50). On May 2, 2013, you were sent a letter informing you of your obligation to provide mitigation for depletions to the Big Lost River due to your use of groundwater. The letter identified several options for providing that mitigation and required that users who do not intend to participate in a mitigation plan sponsored by Water District No. 34 should submit an alternative mitigation plan to IDWR by May 17, 2013. The purpose of this letter is to notify you of a meeting to be held by Water District No. 34 at the time and place shown below and to extend the time for submittal of an alternative mitigation plan.

Mackay High School Auditorium

The purpose of meeting is to discuss the proposed plan for the water district to acquire water supplies pursuant to Rule 50.04.d to mitigate for depletion due to groundwater pumping. You are encouraged to attend the meeting to help you determine whether you will participate in the water district's mitigation plan or provide alternative mitigation. As the meeting is scheduled after May 17, 2013, the date for submitting an alternative mitigation plan has been extended to May 31, 2013. If IDWR has not received an alternative mitigation plan by that date, junior groundwater users will be presumed to be participating in the water district-sponsored plan and will be assessed by the water district for the expense of providing mitigation under that plan. The assessments to pay the costs of the mitigation plan will be allocated based on each groundwater user's proportion of water usage in 2012. If you will not use your well in 2013, you will not be required to participate in a mitigation plan, and you will not be assessed for the costs of the water district plan.

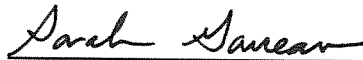
