Nick Miller read the 2013 meeting minutes and asked if there were any questions, additions or amendment. Wayne Baker made motion to accept the minutes and Gary Ingram second the motion. Motion passed unanimously.

The meeting Chairman read the Watermaster Report and the Treasurer's Report. There was discussion on the pay level for the Watermaster, consensus was that the set amount is within the standard.
