

Introduction / Summary

It was the best of times, it was the worst of times

The 2015 irrigation season started out strangely, with a good snowpack, followed by sudden February flooding, then unusually warm temperatures and little apparent hope for sufficient rain. Nevertheless, it turned out to be a good season for us, largely due to unexpected spring and summer rains and cooling temperatures.

The season appeared desperate in late August when the total amount of water in the Jesse, Pollard Canyon, Chipps Creek drainage finally fell to a low level that decreed all the water in the system belonged to the City of Salmon. Even this amount of water was insufficient to fully meet the City's needs.

However, the City decided to "turn on the pumps" and draw Salmon River water into its ponds. (This was also a beneficial move for the City since it allowed them to examine, tune up, and repair the seldom used pumps.) At this point a sudden spurt of water, partially due to a few convenient thunderstorms, arrived in time for the remaining irrigators to salvage the season with the excess water then available for delivery and with cooling temperatures reducing the needs.

There were occasional shortages experienced by some users of the Jesse Lateral Ditch, but the newly existing spirit of cooperation among all the water users minimized hardship.

Silver Peak received a very large amount of water early to midseason and toward the end. Edwards was able to utilize some flows essentially all season. AWD suffered little consequence and used their storage capability efficiently. The City got by, largely with the inclusion of pumping efforts. Blackadars had water as needed and smaller, later priority users were accomodated as much as possible. This season showed the value of the level of cooperation now in existence among Distict 75A users.

Projected budget shares for 2016 will vary only slightly from 2015 budgets.
