RE: Removal of TNC Structures in East Fork Fish Creek; Your Letter Dated 1/29/2020

Dear Mr. Bromley,

I am in receipt of your letter dated January 29, 2020 regarding my correspondence to you on December 2, 2019 extending the deadline for the Water District 37U watermaster to coordinate the removal of 11 man-made structures installed in East Fork Fish Creek by The Nature Conservancy ("TNC") from December 2, 2019 to February 4, 2020.

Your latest letter asks the Idaho Department of Water Resources ("IDWR") to "move the 'removal' deadline from February 4, 2020 to February 25, 2020. You state in your letter that "additional time is still needed to reach a resolution" between your client and TNC" I responded to your letter on January 29, 2020 via email and suggested the parties consider extending the deadline to April 1, 2020 so there is sufficient time for the parties to reach resolution and because irrigation will not likely commence in that area until after April 1. You responded to me by email on February 4, 2020 and advised that the parties had a productive meeting on February 3rd. You further advised that you were authorized to request an extension of the 'removal' deadline to April 1, 2020.

IDWR grants the request to delay removal of the 11 structures from February 4, 2020 to April 1, 2020. By copy of this letter to watermaster Jerry Weaver, IDWR hereby instructs the watermaster to delay coordination of removal of the 11 structures to April 1, 2020.

Once again, IDWR appreciates the time and effort expended by you, FCID and TNC towards resolving this matter.
