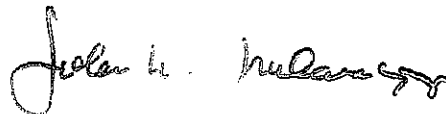
On January 17, 2006, the Idaho Department of Water Resources filed its *Director's Report for Irrigation & Other Uses, Reporting Area 17, IDWR Basin 21*, recommending that the water right claims listed on the attached Exhibit be dismissed. No objections were filed to these recommendations and the time for filing objections has expired.

THEREFORE IT IS ORDERED AND ADJUDGED that the water right claims listed on Exhibit A are hereby **disallowed with prejudice** and shall not be confirmed in any partial decree or in any final decree entered in the SRBA, Case No. 39576, in whatever form that final decree may take or be styled.
